NOTE: This matter has been coordinated with the Identification Division, which will provide access to the Oswald prints which are maintained by that Division. In this connection, while searching Bureau files for latent prints requested, on 5/17/78, Mr. Philip T. Brookman, GS-5, Congressional Inquiry Unit, located a Dallas Police Department original arrest fingerprint card for Lee Harvey Oswald. The card was initialed by a "WEB" on 11/22/63 and signed by "J.B. Hicks." Attached to the card were two original Oswald palm prints. These documents were found in Bureau file 62-109060, bulky 5846, behind guide card entitled "Prints of Oswald," which was attached to an envelope entitled "Latents of Oswald not used for Commission report." On 5/18/78, the original fingerprint card and two original palm print cards were turned over to Deputy Assistant Director Banner, Identification Division, for safekeeping.

In order to find all latent prints requested, all John F. Kennedy files must be reviewed. Therefore, HSCA is being invited to locate those they wish as Congressional Inquiry Unit has no time for such Committee research.

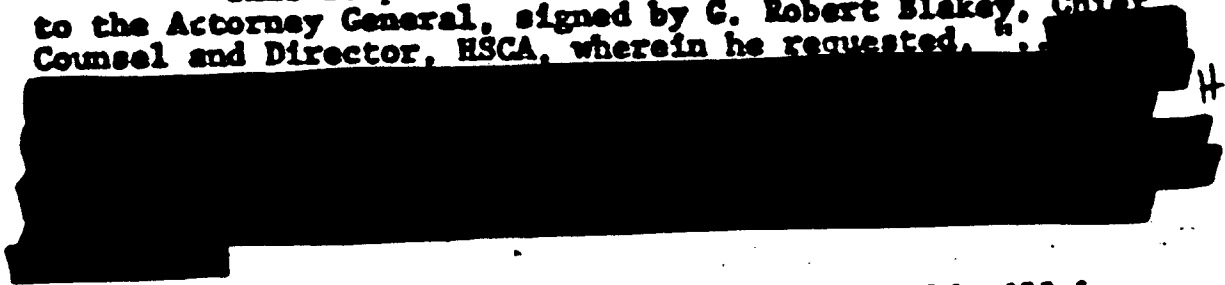

PURPOSE: To obtain approval for handling certain informant matters resulting from captioned Committee's investigation into the assassination of John F. Kennedy and Martin Luther King, Jr.

SYNOPSIS: Through intensification of the HSCA's investigation into the Kennedy and King assassination cases, three problem areas have arisen concerning informant matters. Discussed during a conference on 5/26/78 at FBI Headquarters (FBIHQ), these problem areas are (1) Desire of the HSCA to interview unidentified current or former Bureau informants (2) Situation where an informant is subpoenaed to testify before the HSCA when his identity is not known to the Committee, and (3) Situations where the HSCA has determined an informant's identity, interviewed him, and obtained a waiver authorizing HSCA access to his FBI file. Recommended policy for handling each problem area is set forth in details. If approved, the Department of Justice should be briefed regarding these problem areas and our policy for each. Information concerning the HSCA should be updated for all Field Offices and Legats with reminder for the Field to promptly refer to FBIHQ any contact by HSCA representatives with FBI personnel and/or informants.

DETAILS:

BACKGROUND: Since approximately December, 1976, the HSCA has been conducting investigation into the assassination of John F. Kennedy and Martin Luther King, Jr. The HSCA has been given access to voluminous FBI files involving many aspects of FBI operations, some of which contain informant information where informant identity protected. As the Committee's investigation nears conclusion, believed to be December, 1978, approximately 40 days of public hearings are

scheduled for the Fall of 1978. These hearings will involve appearances of witnesses, some of whom may be FBI informants whose identities may or may not be known to the HSCA. In addition, the HSCA staff will be conducting interviews, some of which will involve informants and former informants of the FBI.

FBIHQ MEETING 5/26/78: In order to propose a sound policy regarding informant matters as related to the HSCA, a meeting was held on 5/26/78, attended by Agents of the Congressional Inquiry Unit and the following: David Ryan, Records Management Division; D. O. Coulson, Legal Counsel Division; and M. V. Hale, Top Echelon and Criminal Informant Unit, Criminal Investigative Division. The following three problem areas were defined and recommendations for handling each of these situations are set forth as follows.

INFORMANT PROBLEM AREAS:

1. Desire of HSCA to Interview an Unidentified Current or Former Bureau Informant

To date, in several specific instances, the HSCA has reviewed information furnished by an informant whose identity has been protected, whom the HSCA feels the need to interview. The HSCA has asked the FBI to contact the informant and determine if he is agreeable to HSCA staff interview. Our policy has been to contact the informant and advise him of HSCA interest. He is told that we have not disclosed his informant status, but the HSCA may know his name through review of substantive FBI files or other investigative techniques. If the informant objects to interview, the Committee is advised to that effect. If he has no objection, the informant is given the name and telephone number of a staff member of the HSCA. In this way, it is the informant who furnishes his identity to the HSCA and not the FBI. Also, the informant can negotiate personally with the Committee concerning the location, nature and scope of the interview.

During the conference on 5/26/78, it was proposed that the above policy was sound though somewhat incomplete. In addition, it was desired that upon initial contact with

the informant to determine if he would agree to interview by the HSCA, the informant should also be told the following: That he has no guarantee from the FBI or HSCA of immunity or confidentiality; that the FBI is not responsible for what resulting action the HSCA may take following interview; that since the Committee may already know his identity, he could be subpoenaed to testify; and, that if he does not want to be interviewed, the FBI will do everything in its power to protect his identity. These matters should be presented objectively to the informant by contacting Agent.

2. Witness Situation - Where Informant is Interviewed or Subpoenaed to Testify Before the HSCA When it is Not Known to the Committee that He is an FBI Informant

In one instance to date [REDACTED] has been interviewed by HSCA staff personnel and subsequently subpoenaed to testify before the HSCA. Informant has sought our advice as to his reply if asked during testimony if he is or has been an FBI informant. (b)(7)(D)

At the conference on 5/26/78, it was proposed that if the informant has no objection to his identity being disclosed during HSCA interview or testimony, then he should be told the FBI is agreeable to this disclosure (if that is the case). If informant does not want his confidential relationship revealed during testimony, we will suggest the following. If he has no objections, FBIHQ will present his situation to Congressman Louis Stokes, HSCA Chairman; Congressman Sam Devine, HSCA Ranking Minority Member; and to G. Robert Blakey, HSCA Chief Counsel and Director, in an effort to prevent questioning concerning his informant status. If neither of the above possibilities is acceptable to the informant, he will be told that if he testifies, he should use his own initiative in responding to Committee questions. He will be told, however, that if he decides to answer questions, he must be truthful.

3. Situations Where HSCA Has Determined an Informant's Identity, Interviewed Him, and Obtained a Waiver Authorizing HSCA Access to the FBI Records, Including Those Involving His Confidential Relationship

In several instances to date, the HSCA has provided a waiver as described above, attached to a request for all files and references concerning the informant. These waivers have been honored without verification, based on the credibility of the HSCA and the fact that a copy of the waiver was attached to a letter to the Attorney General and signed by Mr. Blakey. Subsequently, files were processed for HSCA access, and in two cases requests for delivery of informant files were honored.

At the conference on 5/26/78, it was proposed that in the future the FBI Field Office would contact the informant and verify the authenticity of his waiver.

Subsequent to the conference, Assistant Director Mintz, Legal Counsel Division, advised it would be in the best interest of the Bureau in protecting against civil suits to obtain our own waiver from the informant, rather than rely on any waiver which informant furnished under unknown circumstances to the HSCA. Our waiver will be worded so as to authorize the FBI to release any and all files (FBIHQ and Field Office) concerning this informant to the HSCA, including those records pertaining to any confidential relationship the informant may have had with the FBI. This waiver will state that the informant understands that these files will disclose to the HSCA any confidential relationship informant may have had with the FBI. If this waiver is signed by informant, then his informant file will be processed for the Committee with excisions allowed by the Memorandum of Understanding, between the Department of Justice and HSCA. These excisions are primarily to protect other informants, third agency information, foreign agency information and sensitive investigative techniques. Unless unusual circumstances exist, informant files processed as a result of the waiver will not be delivered, but only made available for HSCA access at FBIHQ.

GENERAL INFORMATION: The above problem areas and recommended policy for handling each is set forth for general information and approval. It is recognized that before the HSCA expires, other situations involving informants will occur which fall outside the scope of those outlined above. These situations will be reviewed separately and coordinated with appropriate FBIHQ Divisions.

In addition, if the above procedures are approved, each will be discussed by Legal Counsel Division with Robert L. Keuch, Special Assistant to the Attorney General, who is liaison official between the HSCA and the Department of Justice.

FIELD OFFICES AND LEGATS: At inception of the HSCA review, by teletype dated 11/24/76, all Special Agents in Charge and Legats were alerted to creation of the HSCA and that some members of the HSCA staff may attempt to interview our employees in the Field. This teletype instructed that any attempts by the HSCA to obtain information through Field personnel or any other matters pertaining to the HSCA should be promptly furnished to FBIHQ.

Because of intensified investigation by the HSCA and scheduled public hearings, particularly where informants may become involved, the Field should be reminded of the contents of our teletype of 11/24/76 and additionally alerted to the possibility that the Committee may be interviewing current or former Bureau informants and subpoenaing them to testify.

RECOMMENDATIONS:

1. That policies outlined in informant problem areas Number 1, 2 and 3 be approved as stated above.

Following arrival at the Naval Medical Center and preparation of the President's body for inspection and autopsy, to be performed by Dr. HUMES, Chief Pathologist and Commander, United States Navy, Admiral BERKLEY, the President's personal physician, advised that Mrs. KENNEDY had granted permission for a limited autopsy and he questioned any feasibility for a complete autopsy to obtain the bullet which had entered the President's back.

At this point, it will be noted Dr. HUMES, a United States physician conducting the autopsy, stated it was his opinion that the bullet was still in the President's body and could only be extracted through a complete autopsy, which he proposed to do.

Special Agent ROY KILLEYMAN, Secret Service, in conference with Special Agents SIBERT and O'NEILL, from an investigative and prosecutive standpoint, advised Admiral BERKLEY that it was felt the bullet should be located.

At this point, Admiral C. B. GALLOWAY, Commanding Officer of the National Naval Medical Center, Bethesda, Maryland, told Commander HUMES to perform a complete autopsy.

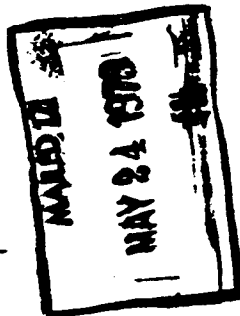
