PURPOSE:

To record events surrounding the transmittal of above referenced file by SA Parks H. Stearns from SA Orley Leeson of the Identification Division to SA John S. Giaquinto of the Records Management Division.

DETAILS:

Shortly before 4:00 p.m. 6/15/78, Mr. Orley Leeson, Assistant Section Chief of the Technical Section, Identification Division, telephonically inquired of SA Parks H. Stearns of the Legal Liaison and Congressional Affairs Unit, Legal Counsel Division, as to whether that Unit handled liaison with the HSCA. SA Stearns advised that that Unit did have liaison responsibilities with the HSCA. SA Leeson then indicated that one of the employees under his supervision had located a file apparently relating to work done in connection with that Select Committee outside the building earlier that day.

SA Stearns then went to SA Leeson's office and inspected a 3 or 4 page heavily excised Bureau file with the cover reversed bearing a white 3X5 tag reading " [redacted] (b)(7)(c) Miscellaneous References HSCA: 3/14/78."

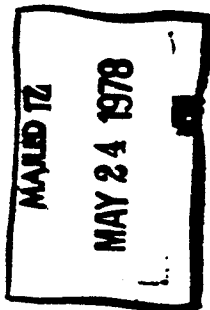

PURPOSE: To alert each division within FBI Headquarters (FBIHQ) of the circumstances surrounding a missing enclosure consisting of certain pages from the Manual of Instructions prepared in response to a request from the House Select Committee on Assassinations (HSCA) dated February 15, 1978.

DETAILS: The CIU handles requests from the HSCA pertaining to information in Bureau files concerning the assassinations of President John F. Kennedy and Dr. Martin Luther King, Jr. An HSCA request dated February 15, 1978, requested certain sections from our Manual of Instructions in use during 1962-1968. This material was prepared in a communication dated May 26, 1978, directed to the Assistant Attorney General, Criminal Division, and the excised manuals were attached as enclosures. The original and yellow copy of the outgoing communication together with enclosures, were last seen in the Legal Liaison and Congressional Affairs Unit, Room 3658, approximately May 30, 1978. The enclosures apparently became unattached as the original and yellow copy of the outgoing communication were located and have never left the Bureau.

The excised portions of the Manual of Instructions are in two bound Bureau file jackets and together are approximately three inches thick. The cover of the file jackets reads as follows: "Manual of Instructions, Table of Contents, HSCA request February 15, 1978". They were then placed in a bulky enclosure folder which was labeled "Manual of Instructions, Table of Contents, Requested Sections, HSCA request of February 15, 1978". Attached to this memorandum is a photograph of the Manual of Instructions prepared by CIU and the bulky enclosure folder.

In response to the above request, Attachment 1 contains the table of contents beginning on January 1, 1962, for the entire FBI MOI, followed by revisions for each year through 1968.

After the Base Manual for each Section are revised pages for each following year up through 1968. Revised pages were issued periodically throughout any given year. Therefore, by appropriately inserting excised pages, the HSCA can reconstruct each Section of the Manual as it would have existed for any month or year of the HSCA's interest. The HSCA should note that the MOI Section concerning murder was not added as Section 146 until June 13, 1973, and is, therefore, outside the period of HSCA's interest. The HSCA should also note that Section 28, Conspiracy, was changed in 1964, with Section 28 becoming the Civil Rights Act of 1964 and Section 29 becoming Conspiracy. There were no revised pages for Section 29 for the years, 1965 to 1968.

This letter completes response to HSCA's letter of February 15, 1978.

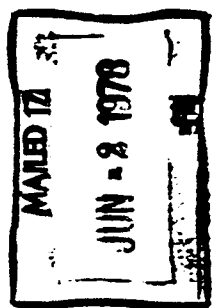
