## WALLACE BENNETT TIME MAGAZINE INQUIRY RE MARINA OSWALD

Wally Bennett called from Time magazine just before noon today and spoke with Leinbaugh in my office. Bennett said he had just received a most urgent request from. his New York office requesting that he contact the FBI to see if we could make available any photographs of Marina Oswald. He said that she was to be Time's "cover subject" next week and the magazine was urgently seeking photographs: Bennett then laughed and said that he, of course, knew the answer before he called but had to go through the motions. Leinbaugh told Bennet that he was right that as he well knew we could not make information or photographs available to them.

At 3:55 p. m. $\square$ who is an announcer for CBS, called and spoke to Kemper in my office. He said that he had seen somewhere that'Maria Oswald's father was a Russian intelligence official and wondered if we had any comment. Kemper told him we had no comment on it.
$670 \quad$ said he also heard that Oswald had an excellent memory and had memorized all of the codes when he was stationed with the Marine Corps on the West Coast. He was advised we could make no comment.
bD said that he had just come from a news conference where Maria Oswald had been interviewed. She told the press as follows:

1. That her husband told her that he had shot General Walker.
2. When asked why she did not report this to the police, she said "I am a wife."
3. She said she did not know whether her husband was trying to shoot the President or Governor Connally, that he had never said anything bad about either one of these individuals.

He said that there had been quite an uproar caused in the various local churches because a directive has come from the head of the Presbyterian Church in Chicago urging that all churches put a piece in the church letters and take up a collection for Marina Oswald. He said he is greatly opposed to this and wondered if there is any information which we could give him which would indicate that Oswald was the assassin and which would help him in his fight against taking up such a collection. He said he called the "Dallas News" and had learned that Mrs. Oswald, wife of the assassin, had already received $\$ 40,000$ and that she was going to get $\$ 50,000$ from syndicated newspaper items.
