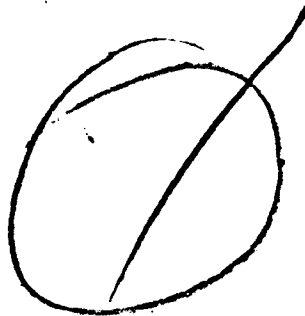
Dear Sirs:

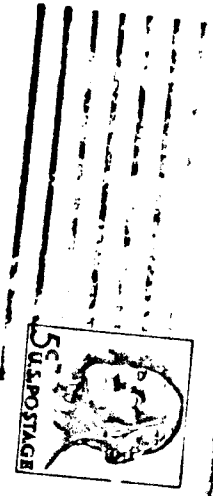

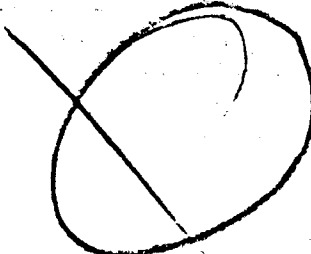

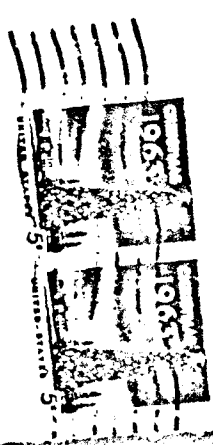
