MORRIS BLOCK, FIVE FIVE ONE ZERO EDGEWOOD PLACE, LOS ANGELES, ADVISED SA FRANK H. TWONSEND, NOVEMBER TWENTY FIVE

INSTANT, HE KNEW RUBY VAGUELY IN CHICAGO AS A BAR OPERATOR DURING THE NINETEEN THIRTIES IN THE VICINITY OF MADISON STREET AT SACRAMENTO, MADISON AT KELSEY, OR MADISON AT CRAWFORD, IN CHICAGO. AT THAT TIME, ACCORDING TO BLOCK, ANY BAR OPERATOR WAS REQUIRED TO HANDLE THE CAPONE-S MOB QUOTE CANADIAN ACE UNQUOTE BEER AND TO PAY TRIBUTE TO THE POLICE CAPTAIN COMMANDING THE AREA PRECINCT. BLOCK CLAIMS INABILITY TO RECALL THE NAME OF THE POLICE CAPYTAIN WITH WHOM HE PERSONALLY DEALT BUT BELEIVES IT WOULD BE THE SAME OFFICIAL WITH JURISDICTION OVER MADISON STREET AT THE ABOVE INTERSECTIONS.
