OPERATORS OF CHAD/S ROSE ROOM. CHADWICK INFORMED ALL HIS "STRIPPERS" ARE SECURED THROUGH BOOKING AGENCY IN ATLANTA AND THAT RUBY IS UNKNOWN TO HIM. M. LAMAR MURPHY, SHERIFF, RUSSELL CO. AND JOHN HENRY EAST, DEPUTY SHERIFF, PHENIX CITY, STATED RUBY UNKNOWN TO THAT OFFICE AND HAS NO RECORD OF ARREST. BOTH CONFIRMED THAT PHENIX CITY HAS NO SUPPLY OF "STRIPPERS".

[REDACTED] WHO HAS WIDE ACQUAINTANCE AMONG FORMER NIGHT CLUB OPERATORS, TAVERN OPERATORS AND GAMBLERS IN PHENIX CITY AREA STATED HE IS CERTAIN RUBY HAS NO CLOSE CONNECTIONS IN PHENIX CITY AND HAS NEVER OPERATED THERE. RUBY UNKNOWN TO INFORMANT. INFORMANT CONFIRMED INFO THAT PHENIX CITY HAS NO SOURCE OF "STRIPPERS".

ALL INFORMANTS MOBILE DIVISION, COGNIZANT OF GAMBLING ACTIVITIES, NEGATIVE RE RUBY AND OSWALD.
