UNTIL OCT. SIXTYONE, AT WHICH TIME HE MOVED TO DETROIT, MICH.

DURING NINETEEN FORTY, EARL RUBY EMPLOYED AS
CARPENTER AT THE GREAT LAKES NAVAL TRAINING SCHOOL NEAR CHICAGO.

EARL RUBY MARRIED MARGE GREENE, SEVENTEEN YEARS AGO,
AND THEY STILL RESIDE SOUTHFIELD, MICH., AS MAN AND WIFE.
SEVERAL YEARS AGO, EXACT DATE UNKNOWN, EARL RUBY, HAD HIS NAME
LEGALLY CHANGED FROM RUBENSTEIN TO RUBY. NOT BELIEVED INDIVIDUAL
