ASSASSINATION OF PRESIDENT JOHN F. KENNEDY, NOVEMBER TWENTYTWO,
ONE NINE SIX THREE. AFO.

A WOMAN IDENTIFYING HERSELF AS ELAINE MYNIER, ROOM THREE
ZERO ONE, SPAULDING HOTEL, SAN FRANCISCO, TELEPHONE GA ONE - 7111
TWO SEVEN ONE FIVE CONTACTED SF OFFICE AND IDENTIFIED HERSELF
AS THE PERSON WHO HAD RECENTLY BEEN RAPED BY TWO SFPD OFFICERS,
A CASE WHICH HAS RECEIVED CONSIDERABLE LOCAL PUBLICITY. MYNIER
STATED THAT SHE CAME TO SF FROM DALLAS ABOUT A YEAR AGO, HAD
LIVED IN DALLAS FOR MANY YEARS PRIOR TO THAT TIME WHERE SHE
WAS EMPLOYED AT NATIONAL CAR RENTALS, DALLAS AIRPORT. PRE-
SENTLY WORKS FOR SAME CONCERN IN SF. STATED SHE WAS WELL AC-
QUAINTED WITH JACK RUBY AND DID NOT BELIEVE HE HAD COURAGE
ENOUGH TO KILL ANYONE AND DID NOT BELIEVE HE HAD ENOUGH PAT-
RIOTISM TO BE UPSET RE PRESIDENT-S ASSASSINATION. SAID THAT
IN MAY FOLLOWING THE JANUARY WHEN CASTRO TOOK OVER CUBA, SHE
TOOK A PLEASURE TRIP TO CUBA, SAID THAT RUBY SAW HER AT THE

AIRPORT AND GAVE HER A SHORT WRITTEN MESSAGE IN CODE CONSISTING OF LETTERS AND NUMBERS AND INCLUDING THE WORD QUOTE ARRIVING UNQUOTE. THIS WAS TO BE DELIVERED TO L. J. MC WILLIE WHO WAS THEN OPERATING THE GAMBLING AT THE TROPICANA HOTEL IN HAVANA PRIOR TO THE TIME U.S. GAMBLERS HAD TO LEAVE. STATES SHE DELIVERED MESSAGE TO MC WILLIE WHO MADE SOME COMMENT REGARDING RUBY TO THE EFFECT THAT QUOTE HE IS NUTS UNQUOTE. STATES SHE HAS KNOWN MC WILLIE FOR MANY YEARS AND HAS DATED HIM IN THE PAST. SAYS THAT PRIOR TO GOING TO CUBA, HE WAS A WELL KNOWN DALLAS AND FT. WORTH GAMBLER AND IS CERTAIN HE PAID OFF LOCAL POLICE. SAYS HIS WIFE, JUANITA MC WILLIE STILL LIVES IN DALLAS AREA AND SHE LAST KNEW HIM TO BE OPERATING THE GAMBLING IN THE RIVERSIDE HOTEL, RENO, NEVADA PRIOR TO THE TIME THE HOTEL WENT BANKRUPT ABOUT ONE YEAR AGO. SHE DESCRIBED MC WILLIE AS WHITE, AGE FIFTY SIX, STOCKY BUILD, FIVE FT. NINE INCHES, GREY HAIR, BLUE EYES, DISTINGUISHED LOOKING AND WELL DRESSED.
