Source stated that in order to locate a specific call without the credit card number or the name of the holder it would be necessary to review all cards issued in the area.

It is noted that information has been developed indicating that the source of the information concerning the alleged calls may not be reliable. Investigation is continuing to resolve this matter and WFO will hold in abeyance further investigation concerning the credit cards pending receipt of further investigation.
