SAM GORDON, SEVEN FIVE FIVE CRESCENT DRIVE, PALM  
SPRINGS, CALIFORNIA, OWNER OF RESTAURANTS IN SACRAMENTO AND  
SAN FRANCISCO, WITH OFFICE ADDRESS ONE SIX TWO SIX QUOTE J UNQUOTE  
STREET, SACRAMENTO, ADVISED ON NOVEMBER TWENTY SIX INSTANT, AS  
FOLLOWS---

GORDON, IN NINETEEN THIRTY ONE, MET JACK RUPENSTEIN,  
AKA SPARKY, WORKING AROUND THE BASEBALL PARK, CHICAGO, WHERE  
THEY WERE BOTH SELLING NOVELTIES AND SCALPING TICKETS TO THE  
GAMES. SPARKY LIVED WITH HIS PARENTS, NAMES AND ADDRESS  
NOT RECALLED, SPARKY AND GORDON DOUBLEDATED AND WENT TO  
DANCES TOGETHER. GORDON COULD NOT RECALL THE NAMES OF ANY  
OF THEIR ASSOCIATES.

IN NINETEEN THIRTY FIVE, GORDON MOVED TO SAN FRANCISCO, WHERE HE RAN INTO SPARKY. THEY RENEWED THEIR FRIENDSHIP. SPARKY LIVED WITH HIS SISTER, EVA PAREN LNU UNPAREN AT A CHEAP APARTMENT HOUSE, ADDRESS NOT RECALLED. GORDON RECALLED SEEING EVA, BUT DID NOT KNOW HER ASSOCIATES OR EMPLOYMENT. SPARKY WAS EMPLOYED AS A DOOR TO DOOR, DAILY NEWSPAPER SUBSCRIPTION SOLICITOR. SPARKY RETURNED TO CHICAGO IN NINETEEN FORTY, AND GORDON HAS NOT SEEN OR HEARD FROM HIM SINCE. GORDON WAS NEVER BEEN IN DALLAS, AND DOES NOT KNOW ANY OF HIS ASSOCIATES THERE. SPARKY, DURING THE TIME GORDON KNEW HIM, NEVER EXHIBITED ANY EXTREMIST OR RADICAL VIEWS, NEVER CARRIED A GUN, WAS NOT MIXED UP IN ANY ILLEGAL ACTIVITY, NEVER EXHIBITED ANY PARTICULAR INTEREST IN POLITICAL ACTIVITIES, AND NEVER STARTED ANY ARGUMENTS OR FIGHTS EVEN THOUGH HE WAS QUITE QUOTE GOOD

"PAUL ADMITS HOLDS FIFTY PERCENT OF STOCK IN S AND R INC., TEXAS CORPORATION, <sup>OWNER</sup> ~~OWNER~~ OF CAROUSEL CLUB OPERATED BY JACK RUBY.

DAVIS, RECORDS ADMINISTRATION SECTION, INS, NYC, ON ELEVEN TWENTY NINE INSTANT ADVISED THAT CHECK OF INS RECORDS, NYC, FAILE TO REFLECT RECORD OF RALPH PAUL AKA RAPHAEL PAUL, OR HIS PARENTS, SAMUEL PAUL AND TILLIE PAUL. DAVIS POINTED OUT THAT ALL INS RECORDS INVOLVING NATURALIZATION OR DERIVATIVE CITIZENSHIP PRIOR TO FOUR ONE FIFTY SIX ARE NOW LOCATED INS CENTRAL OFFICE, WASHINGTON, DC.

NY IS CHECKING RECORDS OF US DISTRICT COURT, SDNY, AND EDNY IN EFFORT TO LOCATE NATURALIZATION RECORD OF PARENTS OF PAUL.

WFO REVIEW INS CENTRAL OFFICE FILES AND IF RECORD LOCATED FOR RALPH PAUL OR HIS PARENTS ADVISE NYO DATE AND PLACE WHERE NATURALIZATION OF PARENTS AND /OR DERIVATIVE CITIZENSHIP GRANTED TO RALPH PAUL.
