UPI TEAM, WENT TO DALLAS FRIDAY NOVEMBER TWENTY TWO VIA PLANE ARR
IVING DALLAS IN EVENING OF THAT DAY.

ON NOVEMBER TWENTY TWO HE ENTERED AND LEFT

DALLAS PD BUILDING SEVERAL TIMES AND ON OCCASION HAD HIS

PRESS PASS INSPECTED BY UNIFORMED POLICEMAN BUT ADDED QUOTE

THEY GOT TO KNOW US, UNQUOTE. INITIALS QUOTE UPI UNQUOTE ARE

ON ALL NEWSGEAR CARRIED BY OAKES AND HE SOMETIMES ENTERED

BUILDING WITHOUT SHOWING PRESS CARD WITH POLICE OFFICERS ASSUMING

GORR-FIRST LINE OF LAST-PARA SHLD READ

ON NOVEMBER TWENTY-TWO-AND-TWENTY THREE HE ENTERED AND LEFT—ETC.

HE WAS A NEWS PERSON BASED ON IDENTIFICATION ON NEWSGEAR. HE ARRIVED AT DALLAS PD NINE THIRTY AM. ON ELEVEN TWENTY FOUR AND ENTERED BASEMENT OF PD VIA MAIN STREET RAMP. IT HAD BEEN PREVIOUSLY ANNOUNCED BY CHIEF OF POLICE THAT IF NEWSMEN ARRIVED AT PD BY TEN AM, THAT DAY THAT WOULD BE EARLY ENOUGH TO COVER OSWALD/S TRANSFER TO COUNTY JAIL. HE WAS CARRYING SEVERAL PIECES OF EQUIPMENT AND SUITCASES CONTAINING PHOTOGRAPHIC EQUIPMENT, ALL BEARING INITIALS UPI AND CANNOT RECALL WHETHER OR NOT HE HAD TO SHOW PRESS PASS OR NOT. HE BELIEVES HE WAS POSSIBLY PERMITTED TO ENTER BY YOUNG NEATLY DRESSED UNIFORMED OFFICER BASED ON UPI IDENTIFICATION ON EQUIPMENT. OAKES LEFT PD TEN FORTY AM THAT DAY TO COVER NEWS CONFERENCE BEING HELD BY WIFE OF GOVERNOR CONNALLY AT PARKLAND HOSPITAL. HE WAS ADVISED OF OSWALD/S SHOOTING WHILE AT HOSPITAL AND WAITED AT THE HOSPITAL A WHILE IN ATTEMPT TO COVER OSWALD/S ARRIVAL AT HOSPITAL BUT WAS INSTRUCTED BY SISCO TO RETURN TO PD AND DID NOT SHOOT ANY FILM OF OSWALD AT HOSPITAL. UPON RETURN TO PD, HE ENTERED VIA MAIN STREET RAMP TO BASEMENT AND HAD TO EXHIBIT PRESS PASS TO UNIFORMED OFFICER TO GAIN ENTRANCE. A SECOND END PAGE TWO...

MEASURES AND THAT ANY TIME HE WAS PERMITTED ENTRANCE WITHOUT

EXHIBITING PRESS PASS IT OCCURRED WHEN HIS NEWS EQUIPMENT WAS

CLEARLY MARKED QUOTE UPI UNQUOTE. OAKES HAS NO KNOWLEDGE OF

UNAUTHORIZED PERSONS IN BASEMENT OF PD OR PERSONS PRESENT WHO

DID NOT HAVE PROPER IDENTIFICATION, OTHER THAN FACT THAT PAUL

SISCO OF UPI TEAM COMMENTED DURING PRESS CONFERENCE WITH CHIEF

OF POLICE ON ELEVEN TWENTY SIX THAT JACK RUBY WAS PRESENT AT

OSWALD/S PRESS CONFERENCE ONE AM, ELEVEN TWENTY THREE.

IT IS NOTED SISCO PREVIOUSLY INTERVIEWED CONCERNING THIS
AND STATED THAT HE COULD NOT DEFINITELY SAY IT WAS RUBY BUT FELT
IN RETROSPECT IT MUST HAVE BEEN HIM. SISCO RECONTACTED TWELVE ONE
BY SA MC KINNEY AND ADVISED THAT HE DOES NOT RECALL DEFINITELY REFERRING TO THIS INDIVIDUAL AS RUBY BUT IF HE DID, IT WAS BASED ON ASSUMPTION OF ALL NEWSMEN PRESENT AT ELEVEN TWENTY THREE PRESS CONFERENCE
