SHE SAID RUBY WAS ERRATIC IN BEHAVER AND FURNISHED FOLLOWING EXAMPLES. HE GAVE HER DAY OFF AS WAITRESS AND FOLLOWING DAY PEPPER WAS TOLD-SHE WAS DISCHARED BECAUSE NOT HOME ON DAY OFF AND COULD ONLY WORK THEREAFTER AS DANCER, WHICH SHE DID. ONCE SHE COMPLAINED TO RUBY ABOUT HER DANCE COSTUMES BEING DISARRAYED IN CAROUSEL DRESSING ROOM WHERE STORED AND RUBY BECAME VERY ANGRY AND TOLD HER TO TAKE CARE OF OWN COSTUMES.
