SHOOTING THIS DATE OF LEE HARVEY OSWALD, CHARGED WITH
ASSASSINATION OF PRESIDENT KENNEDY.

JACK LEON RUBY, IN MARCH FIFTYNINE, RESIDED
FOUR FIVE SIX ZERO HAWTHORNE ST., DALLAS, LA EIGHT DASH FOUR
TWO FOUR THREE, OPERATED VEGAS CLUB, THREE FIVE ZERO EIGHT OAK
LAWN, DALLAS, PHONE LA EIGHT DASH FOUR SEVEN SEVEN FIVE. HE
WAS BORN MARCH TWENTYFIVE, NINETEEN ELEVEN, CHICAGO, ILL., FIVE
FEET NINE, ONE HUNDRED NINETY FOUR POUNDS, BUILD HEAVY, BROWN HAIR
AND EYES, MEDIUM COMPLEXION, RACE WHITE, FINGERPRINT CLASSIFI-
CATION NINETEEN, L OVER M, NINE OVER ONE, U OVER U, OIM OVER OII,
SEVEN OVER SIX, FINGERPRINTED DALLAS PD, THEIR NO THREE

AUGUST, FIFTYTHREE, JACK RUBY, OPERATOR, SILVER SPUR, ONE SEVEN ONE SEVEN S. ERVAY ST., DALLAS, WAS OBSERVED BY A SA, FBI, IN OFFICE OF AMERICAN GUILD OF VARIETY ARTISTS, DALLAS, MAKING DEMANDS THAT GIRLS BE SUPPLIED FOR ENTERTAINMENT AT HIS CLUB. RUBY WAS EXTREMELY ARGUMENTATIVE AND THREATENING AND ASKED BRANCH MANAGER, AGVA "DO YOU WANT TO KNOW WHETHER OR NOT I AM PACKING A GUN," "WHAT ARE YOU TRYING TO DO BE A TOUGH GUY IN DALLAS." "WELL I AM JUST ABOUT AS TOUGH AS THEY COME."

VINCENT LEE, BRANCH MANAGER, ADVISED SA, RUBY WAS AN ASSOCIATE OF JOE BONDS, OPERATOR OF SKY CLUB, DALLAS, AND KNOWN DALLAS AREA CRIMINAL AT THE TIME AND THAT BONDS AND RUBY ALWAYS CARRIED CONCEALED WEAPONS, THAT RUBY WAS AN ASSOCIATE OF JACK TODD, [REDACTED] THAT THESE

IN INTERVIEW TODAY, RUBY ADVISED HAD NAME LEGALLY
CHANGED TO JACK RUBY FROM JACK RUBENSTEIN IN DALLAS. NOW
RESIDES TWO TWO THREE S. EWING, DALLAS. CLAIMS SERVED IN
ARMY AIR CORPS, NINETEEN FORTYTHREE DASH FORTYSIX, SN
THREE ZERO SEVEN SIX SIX SIX SIX, CLAIMS MGR. OF CAROUSEL

CLUB AND OWNER OF VEGAS CLUB. CLAIMS TWO YEARS OF HIGH SCHOOL, STATES NEVER ARRESTED FOR ANY FELONY. CLAIMS NO ONE ELSE INVOLVED IN SHOOTING. NO ONE KNEW HE WAS GOING TO DO IT, MADE NO ANONYMOUS PHONE CALLS AND DID NOT GO TO PD FOR PURPOSE OF SHOOTING OSWALD. DECLINED TO SAY WHY HE DECIDED TO KILL OSWALD. CLAIMS OWNED GUN, S AND W THIRTYEIGHT SPECIAL REVOLVER FOR ABOUT THREE YEARS, SN NOT IMMEDIATELY AVAILABLE. RUBY HAD OVER TWO THOUSAND DOLLARS IN CASH ON PERSON WHEN ARRESTED. STATES PARENTS, JOSEPH AND FANNIE RUBENSTEIN, CHICAGO, BOTH DECEASED. RUBY STATES HE SUPPOSED HIS GRIEF OVER PRESIDENT'S DEATH DROVE HIM TO POINT OF INSANITY.
