ROBERT CLARK, SISTER-IN-LAW OF JUSTICE TOM CLARK. COLLINS HAD INDICATED TO SDPD THAT HE WAS FROM DALLAS, TEXAS AND MENTIONED NAMES OF HIS GOOD FRIENDS JOHN F. KENNEDY AND LYNDON B. JOHNSON. COLLINS ADVISED THIS OFFICE THAT HE DESIRED TO MAKE A STATEMENT TONIGHT CONCERNING JACK RUBY. HE STATED THAT HE HAS BEEN A CLOSE PERSONAL FRIEND OF RUBY/S FOR MANY YEARS. HE DESCRIBED HIM AS QUOTE A HERO WORSHIPPER IN LOVE WITH A HERO JOHN F. KENNEDY. GOOD GUY. ALVAYS A GENTLEMAN, SINCERE INTELLECTUAL. AND THE SHOOTING WAS

ECAUSE OF HIS PERSONAL ANIMOSITY OVER THE ASSASSINATION OF PRESIDENT KENNEDY. HE STATED THAT IT WAS OBVIOUS THAT RUBY QUOTE WAITED UNTIL ALL EVIDENCE AGAINST OSWALD WAS IN BEFORE MAKING HIS MOVE UNQUOTE.

COLLINS STATED HE WAS BOTH SURPRISED AND STARTLED OVER RUBY/S ACTION IN THIS MATTER.

COLLINS ADVISED THAT HE RESIDES AT TWO SEVEN ONE THREE
VIA CASA LOMA, SAN CLEMENTE, CALIFORNIA.

FOR INFORMATION OF THE BUREAU AT THE BEGINNING OF THE INTERVIEW COLLINS STATED THAT HE WANTED TO MAKE A PUBLIC STATEMENT IMMEDIATELY CONCERNING THE SHOOTING OF OSWALD. HE WAS ADVISED THAT ANYTHING HE STATED TO THE BUREAU WAS NOT A PUBLIC STATEMENT. HE SAID HE CONSIDERED THE ABOVE INFORMATION TO BE PERTINENT AND HE WANTED IT KNOWN THAT HE MADE SUCH A STATEMENT CONCERNING RUBY. HE WAS ASK IF HE HAD ANY FURTHER INFORMATION CONCERNING THE SHOOTING OF OSWALD AND HE REPLIED THAT HE DID NOT.

FOR FURTHER INFO COLLINS APPEARED TO HAVE BEEN DRINKING
AND BACKGROUND NOISE DURING TELEPHONE CONVERSATION WOULD
