BACKGROUND

THE FOLLOWING INVESTIGATION WAS CONDUCTED AT BAKERSFIELD, CALIFORNIA, BY SA KENNETH W. BROWN/

ON NOVEMBER TWENTYSIX INSTANT, CHIEF OF POLICE HORACE GRAYSON, NATIONAL ACADEMY, ADVISED THAT AN ASSOCIATE OF HIS HAD TOLD HIM THAT A MAN BY THE NAME OF GRIMES, AN EMPLOYEE OF WAYNE REEDER, A BAKERSFIELD REALTOR, PREVIOUSLY KNEW JACK RUBY.

FA THREE FIVE SEVEN TWO NINE. GRIMES RELATED HE KNEW JACK RUBY FOR A PERIOD OF THREE MONTHS DURING THE SUMMER OF NINETEEN FIFTYNINE. GRIMES REPORTED THAT DURING THIS PERIOD HE WAS VICE PRESIDENT OF THE INTERNATIONAL LIFE INSURANCE COMPANY, AUSTIN, TEXAS. HE SAID JAMES E. DUNN, THE SECOND, WAS THEN PRESIDENT OF THIS COMPANY. GRIMES SAID THAT JACK GRIMES, JAMES E. DUNN, AND JOE SLAYTON, WERE DURING THE SUMMER OF NINETEEN FIFTYNINE IN PARTNERSHIP IN THE SOVERIGN ROOM. A CLUB IN AN UPSTAIRS LOCATION ON COMMERCE STREET, ACROSS THE STREET FROM THE ADOLPHUS HOTEL IN DALLAS. GRIMES SAID DURING THE SUMMER OF NINETEEN FIFTYNINE HE HAD BEEN IN DALLAS FOR THE PURPOSE OF SOLICITING MEMBERS FOR THE SOVERIGN ROOM BY CONTACTING PERSONS WHO WERE KNOWN TO HIM BECAUSE OF HAVING PREVIOUSLY BEEN CONTACTED AS LIFE INSURANCE CLIENTS. GRIMES SAID DURING THE THREE MONTH PERIOD HE HAD DAILY CONTACT WITH RUBY. HE SAID THESE CONTACTS WERE HAD EXCLUSIVELY AT THE SOVERIGN ROOM AND THAT HE COULD NOT RECALL EVER HAVING SEEN RUBY OUTSIDE OF THIS LOCATION. GRIMES END PAGE TWO

SAID HE HAD HAD NO CONTACT WHATSOEVER WITH RUBY SINCE
THE SUMMER OF NINETEEN FIFTYNINE AND THEREFORE WOULD
HAVE NO KNOWLEDGE OF HIS PRESENT ACTIVITIES, CONTACTS,
ASSOCIATES, OR HIS CURRENT ATTITUDE. WITH REFERENCE TO
HIS ACTIVITIES BEFORE NINETEEN FIFTYNINE, GRIMES SAID
RUBY TOLD HIM HE PREVIOUSLY RESIDED IN CHICAGO,
ILLINOIS. GRIMES SAID HE KNEW NOTHING ELSE CONCERNING
RUBY/S ACTIVITIES BEFORE NINETEEN FIFTYNINE.

GRIMES SAID HE HAD NEVER DISCUSSED NATIONAL OR
INTERNATIONAL POLITICS WITH RUBY AND, THEREFORE, HAD
NO IDEA AS TO HIS POLITICAL THINKING. HE SAID HE KNOWS
OF NO CONNECTION THAT RUBY MAY HAVE HAD WITH THE
FAIR PLAY FOR CUBA, ANY-POSSIBLE ACQUAINTANCESHIP HE
MAY HAVE HAD WITH LEE HARVEY OSWALD OR ANY RADICAL
OR EXTREMIST VIEWS OR ACTIVITIES RUBY MAY HAVE HAD.

GRIMES SAID HE KNOWS OF NO RELATIVE OF RUBY
WITH THE EXCEPTION OF A SISTER, WHOSE NAME HE NEVER
KNEW, WHO RUBY HAD MENTIONED.

GRIMES SAID DURING HIS ASSOCIATION WITH RUBY, HE
HAD OBSERVED MANY UNIFORMED OFFICERS AND PERSONS IN

PLAIN CLOTHES, WHO HAD BEEN IDENTIFIED TO HIM AS BEING DALLAS DETECTIVES, COME INTO THE SOVERIGN ROOM WHERE THEY WERE CORDIALLY GREETED BY RUBY WHO SEEMED TO BE WELL ACQUAINTED WITH THEM. HE SAID HE COULD NOT IDENTIFY ANY OF THESE OFFICERS BY NAME. HE SAID HE ASSUMED THESE OFFICIALS CAME TO THE SOVERIGN ROOM IN LINE WITH THEIR OFFICIAL DUTIES AS POLICE OFFICERS:

MR. GRIMES SAID THAT DURING THE PERIOD HE KNEW
RUBY, HE FOUND HIM TO BE A PERFECT GENTLEMAN AT ALL
TIMES. HE SAID HE DID NOT SMOKE, DRINK, OR USE FOUL
LANGUAGE. HE SAID RUBY HAD SHOWN HIM A REVOLVER WHICH
HE SAID HE THOUGHT WAS A COLT COLBRA AND THAT RUBY
TOLD HIM HE CARRIED THE GUN AS A REGULAR HABIT INASMUCH
AS HE HAD MADE ENEMIES OVER THE YEARS BECAUSE OF THE
BUSINESS HE WAS IN.

MR. GRIMES SAID JOE SLAYTON AND JAMES E. DUNN
HAD WITHDRAWN THEIR INTEREST IN THE SOVERIGN ROOM
AND THAT IT WAS HIS UNDERSTANDING AN ELDERLY MAN BY
THE NAME OF RALPH FROM FORTH WORTH, TEXAS, AND RUBY
HAD OPERATED THE SOVERIGN ROOM AFTER DUNN AND SLAYTON

WITHDREW THEIR INTEREST. GRIMES SAID THAT RALPH/S COMPLETE
IDENTITY WOULD BE KNOWN TO JOE SLAYTON.

DUNN PUBLICIZES AN INSURANCE REPORTING SERVICE.

GRIMES SAID JOE SLAYTON RESIDES IN DALLAS, TEXAS, WHERE

HE SAID HE UNDERSTANDS HE NOW OPERATES A DRUGSTORE.

GRIMES SAID SLAYTON WOULD BE WELL KNOWN TO PRACTICALLY

ALL THE BUSINESS ESTABLISHMENTS ON COMMERCE STREET IN

DALLAS.

IF NOT ALREADY DONE, LOUISVILLE WILL INTERVIEW
JAMES E. DUNN.

DALLAS WILL INTERVIEW JOE SLAYTON AND THROUGH
