PEORIA, ILL. SUBSCRIBER TELEPHONE SIX SEVEN FOUR DASH EIGHT  
SEVEN THREE THREE.

DR. FONT INTERVIEWED STATED BORN RUBEN GERARDO FONT Y MONT-  
ENAGRO, SEPT. TWENTYFOUR, NINETEEN THIRTYONE AT MATANZAS, CUBA.

DR. FONT IS WM, FIVE FEET EIGHT INCHES, ONE HUNDRED NINETY  
FOUR POUNDS, DARK HAIR AND EYES, HAS ALIAN REGISTRATION NUMBER  
A DASH ONE ONE TWO FOUR FIVE FIVE THREE TWO AND HAS APPLIED FOR  
US CITIZENSHIP. HE ATTENDED HAVANA UNIVERSITY, CUBA MEDICAL  
COLLEGE, ENTERED U. S. AT MIAMI, MAY THIRTYONE, NINETEEN FIFTY-  
SEVEN, BEFORE CASTRO. HE HAS INTERNEED TAMPA, FLORIDA, CHICAGO,  
ILL. AND BEEN EMPLOYED BY ALTON PAREN ILLINOIS END PAREN STATE  
HOSPITAL AND PRACTICED MEDICINE, METAMORA, ILL. FROM APRIL  
NINETEEN FIFTYNINE TO MARCH NINETEEN SIXTYTHREE, WHEN HE OPENED  
MEDICAL OFFICE PEORIA, ILLINOIS.

HIS FATHER, DR. RUBEN G. ~~FONT~~, MD, MANTANZAS, CUBA SUFFERING FROM HEART AILMENT TELEPHONED HIS SON DR. FONT, PEORIA, ILL. SIX FIFTEEN PM LAST NIGHT REGARDING WHEREABOUTS OF MEDICINE HIS SON HAD PROMISED TO MAIL HIM AND INQUIRED ABOUT FAMILY.

AT CONCLUSION OF CALL, ABOUT SIX TWENTYFIVE PM, DR. FONT IN PEORIA ALMOST RECEIVED ANOTHER TELEPHONE CALL, WHEREIN A TELEPHONE OPERATOR INDICATED HAVANA, CUBA WAS CALLING FOR MR. RUBENSTEIN. DR. FONT RELATED NO-ONE THERE BY THAT NAME, THAT THIS MUST BE A MISDIRECTED TELEPHONE CALL. DR. FONT EXPLAINED TO OPERATOR HE HAD JUST TALKED TO CUBA, AND THAT HIS NAME WAS RUBEN G. FONT, THAT THERE WAS NO-ONE THERE BY THE NAME RUBENSTEIN, THAT HE KNEW OF NO SUCH PERSON.

DR. FONT RELATED HE HAD NO FURTHER INFO REGARDING THIS ATTEMPT TO LOCATE A MISTER RUBENSTEIN IN PEORIA.

PEORIA TELEPHONE DIRECTORIES FAILED TO REFLECT ANY SUBSCRIBER BY NAME OF RUBENSTEIN.

DR. FONT APPEARED COMPLETELY COOPERATIVE, DENIES ANY KNOWLEDGE OF OSWALD OR <sup>R</sup>BUBY AND RELATES HE HAS NO PERSONAL KNOWLEDGE OF ANY PRO-CASTRO PERSONS OR ORGANIZATIONS.
