INTERVIEWED AT HIS RESIDENCE ON NOVEMBER TWENTYFIVE, NINETEEN  
SIXTYTHREE BY BUREAU AGENTS, HE STATED JACK PATRICK, BROTHER  
OF LENNY PATRICK, AN INFAMOUS HOODLUM FROM CHICAGO, ILLINOIS,  
MARRIED /FIRST NAME UNKNOWN/ WEINBERG, A DISTANT COUSIN ABOUT  
FOUR TIMES REMOVED OF THE RUBY FAMILY.

RUBY STATED HE WAS IN CHICAGO OVER THE THANKSGIVING

WHOSE FIRST NAME IS ETHEL, BEING A DISTANT COUSIN OF THE RUBY  
FAMILY. RUBY ADVISED ETHEL WEINBERG, <sup>nee PATRICK</sup> DID, IN FACT, MARRY JACK  
PATRICK, HOWEVER, SHE IS NOT RELATED IN ANY WAY TO THE RUBY
