SUBJECT RUBY FIRED ONE SHOT ON PREMISES OF DALLAS PD,  
NOVEMBER TWENTY-FOUR, INSTANT, KILLING VICTIM WHO WAS BEING  
HELD AS ASSASSIN OF PRESIDENT KENNEDY AND A DALLAS POLICE OFFICER  
AND ASSAILANT OF GOVERNOR JOHN CONNALLY, NOVEMBER TWENTY-TWO,  
LAST. MURDER CHARGES FILED BY DALLAS PD AGAINST RUBY.

RUBY, WHITE MALE, BORN MARCH TWENTY-FIVE, NINETEEN-ELEVEN,  
CHICAGO, ILLINOIS, FIVE FEET NINE INCHES, ONE SEVENTY FIVE POUNDS.  
BROWN HAIR, THIN ON TOP, BROWN EYES, LEFT FOREFINGER OFF AT FIRST  
JOINT, CLAIMS SERVED IN ARMY AIR CORPS, FORTY THREE TO FORTY SIX,  
ASH THREE ZERO SEVEN SIX SIX SIX SIX, OR ONE ZERO SEVEN SIX SIX  
SIX SIX, TWO YEARS HIGH SCHOOL EDUCATION, OWNER OF VEGAS CLUB,  
DALLAS, AND MANAGER OF CAROUSEL CLUB, DALLAS, STRIPEASE THEATER,  
CLAIMS NO FELONY ARRESTS, HOWEVER, FINGERPRINTED IN FIFTY-FOUR,  
BY DALLAS PD, THEIR NO. THREE SIX THREE NINE EIGHT, CHARGED WITH

WHICH CLAIMS PURCHASED, DALLAS, ABOUT THREE YEARS AGO, SERIAL NO.  
NOT IMMEDIATELY AVAILABLE. CLAIMS NO ONE KNEW HE WAS GOING TO  
KILL OSWALD, HE HAD TOLD NO ONE, DECLINED TO SAY WHY HE KILLED  
OSWALD OTHER THAN GRIEF OVER KENNEDY'S DEATH MAY HAVE DRIVEN HIM  
TO POINT OF INSANITY.

INFORMATION RECEIVED RUBY MAY HAVE LEFT CHICAGO BECAUSE OF  
UNDERWORLD CONNECTIONS. SOURCE HAS STATED HAD INFORMATION RUBY'S  
SISTER, EYE GRANT WAS FORMERLY CONNECTED WITH CAPONE GANG, CHICAGO.  
DALLAS FILES REFLECT ASSOCIATION OF RUBY WITH KNOWN DALLAS

CRIMINALS INCLUDING BURGLARS AND STRONGARM MEN, MADAMS, PIMPS,  
PROSTITUTES AND GAMBLERS. SUBJECT HAS HAD FORMER CONNECTIONS IN  
DALLAS WITH ROUNDUP CLUB AND SILVER SPUR.

SOURCES, SINCE KILLING OF OSWALD, ALLEGE HE AND RUBY HAVE  
BEEN SEEN TOGETHER, THAT OSWALD HAS FREQUENTED CAROUSEL CLUB,  
OPERATED BY RUBY.

OSWALD DEFECTED TO RUSSIA, FOLLOWING MARINE SERVICE,  
MARRIED, WIFE MARINA, RUSSIAN BIRTH, RE-ENTERED UNITED STATES  
MID SIXTY TWO, HAS ADMITTED WAS QUOTE MARXIST UNQUOTE, HAS HAD INTERES  
IN QUOTE FAIR PLAY FOR CUBA COMMITTEE UNQUOTE. HAD CARD IN TRUE  
NAME THIS ORGANIZATION, SHOWING NEW YORK ADDRESS AS SEVEN NINE NINE  
BROADWAY, TELEPHONE OREGON FOUR DASH EIGHT TWO NINE FIVE, NAME  
V. T. LEE, EXECUTIVE SECRETARY. HAD SECOND CARD IN TRUE NAME FROM  
QUOTE NEW ORLEANS CHAPTER UNQUOTE OF SAME ORGANIZATION, A. T. HIDELL,  
PRESIDENT. OSWALD HAD FICTITIOUS SELECTIVE SERVICE CARD IN POSSESSION  
IN NAME ALEK JAMES HIDELL. OSWALD HAS RECENTLY USED NAME O. H.  
LEE, AT ROOMING HOUSE. INDICATIONS OF POSSIBLE FOREIGN CONTACTS  
OF OSWALD OF SECURITY NATURE. OSWALD HAS LIVED IN NEW ORLEANS,  
LOUISIANA, DALLAS AND FORT WORTH, TEXAS, SINCE RETURN FROM RUSSIA.

LEE HARVEY OSWALD, AKA, ALEK J. HIDELL, O. H. LEE, BORN OCTOBER  
EIGHTEEN, THIRTY-NINE, NEW ORLEANS, LOUISIANA, FIVE FEET NINE INCHES,  
ONE FORTY POUNDS, MEDIUM BROWN HAIR, WORN MEDIUM LENGTH, BLUE  
GRAY EYES, WIFE MARINA, TWO CHILDREN, AGE TWO AND ONE MONTH.

BUREAU INSTRUCTS INVESTIGATION AS TO EVERY PHASE OF RUBY'S LIFE, FULL DETERMINATION TO ALL PAST AND PRESENT ACTIVITIES, ALL INFORMATION OF WHATSOEVER NATURE INDICATING ANY SUBVERSIVE CONNECTIONS SPECIFICALLY ANY CONNECTION WHATSOEVER WITH QUOTE FAIR PLAY FOR CUBA COMMITTEE UNQUOTE, ANY CONNECTION WITH, ACQUAINTANCE WITH, ASSOCIATION WITH OSWALD, ANY INDICATIONS OF RADICAL OR EXTREMIST VIEWS OR ACTIVITIES. OFFICES COVERING LOCATIONS OF RELATIVES, IMMEDIATELY INTERVIEW SAME, SET OUT APPROPRIATE TELETYPE LEADS FOR INTERVIEWS WITH OTHER RELATIVES OR KNOWN CLOSE ASSOCIATES. DEVELOP SUBJECT'S BACKGROUND FULLY, INCLUDING ORIGIN OF PARENTS, ETC.
