EDWARD KASTIL, SEVEN SEVEN TWO EIGHT NORTH KEELER, LINCOLNWOOD,
ILLINOIS, FURRIER IN THE CHICAGO AREA, ADVISED SA RAYMOND F. HOGAN
ON DECEMBER TWO, INSTANT, THAT HE HAS KNOWN JACK RUBENSTEIN AS SPARKY
RUBENS FOR APPROXIMATELY EIGHTEEN YEARS. HE FIRST MET RUBENSTEIN
WHEN THEY BOTH USED TO PARTICIPATE IN PHYSICAL EXERCISES AT THE
SKYLINE ATHLETIC CLUB, ONE EIGHT EIGHT WEST RANDOLPH, CHICAGO. HE
HAS NOT SEEN SPARKY FOR APPROXIMATELY THREE AND ONE HALF YEARS HAVING
HAD DINNER WITH HIM IN CHICAGO AT THAT TIME.

HE RECALLS SPARKY AS BEING A CLAM TYPE OF INDIVIDUAL SOFT
SPOKEN AND A PERSON WHO DID NOT HAVE AN ARGUMENTATIVE OR VIOLENT
NATURE.

IT WAS A COMPLETE SURPRISE TO MR. KASTIL WHEN HE HEARD THAT JACK
RUBY WAS THE MAN THAT KILLED OSWALD BECAUSE, HE REITERATED THAT RUBY
