DEAR MR KENNEDY:

I HAVE WORKED AS A SECURITY OFFICER ON U.S. DEFENSE INSTALLATIONS, DOMESTIC AND OVERSEAS, FOR FIFTEEN YEARS IN VARIOUS RELATIONS TO EMPLOYMENT ETC. I HAVE USED A PUBLIC STENOGRAPHER IN DALLAS RECENTLY I HAVE BEEN IN CORRESPONDENCE WITH THE BUREAU OF YARDS AND DOCKS, U.S. NAVY, CONGRESSMAN JOE POOL AND SENATOR JOHN TOWNE OF WASHINGTON D.C.

BY WAY OF EXPLANATION I ENCLOSE COPIES OF TWO LETTERS. THE ONE TO GUAM WAS COMPOSED AND TYPED FROM 11 A.M. TO 12:30 P.M. ON WED NOV. 27.

I WENT TO ROOM 301 OF THE WHITE PLAZA HOTEL IN DALLAS AND HAD MONTI TIMMONS, A PUBLIC STENOGRAPHER, TYPE THIS LETTER TO DILLINGHAM-POMEROY OF GUAM WHEN THE LETTER WAS FINISHED MISS TIMMONS ASK

"FRANK WHAT DO YOU THINK OF JACK RUBY" STILL HOLDING THE REVOLUTION OF AMERICA IN MY HEART IN THE LOSS OF A BELOVED MAN I REPLIED: "I AM SICK AND DISGUSTED"

MISS TIMMONS WENT ON AND EXPLAINED TO ME THAT SHE WAS THE SECRETARY OF THE CATOUSEL CLUB OWNED BY JACK RUBY AND THAT SHE HAD THE MEMBERSHIP LIST OF THIS CLUB IN HER DESK, THE NAMES OF WHICH WAS WRITTEN IN THE HANDWRITING OF JACK RUBY. WHEN I CASUALLY ASKED HER ABOUT A MEMBERSHIP LIST FOR THE VEGAS CLUB SHE SAID: "FRANK, I UNDERSTAND HE DOES NOT OWN THE VEGAS, THESE MEMBERS BELONG TO THE CATOUSEL CLUB"

WHEN SHE TOOK THE MEMBERSHIP LIST FROM THE SECOND DRAWER ON THE LEFT HAND SIDE AND SHOWED IT TO ME I KNEW THAT THIS WAS INFORMATION OF GREAT IMPORTANCE TO YOU AND THE DEPARTMENT OF JUSTICE. I THEREFORE EXAMINED IT PAGE BY PAGE. MISS TIMMONS STATED THAT HER MEMBERSHIP WAS COMPLIMENTARY DUE TO HER WORK AS SECRETARY. SHE STATED THAT MANY LAW ENFORCEMENT

OFFICIALS AND MEMBERS OF THE PRESS IN DALLAS HOLD MEMBERSHIP IN THE CATHOU AND TO QUOTE: "JACK WAS PARTICULAR ABOUT WHO BELONGS

Below is a description of the list:

1. SOME 17 PAGES OF NAMES AND ADDRESSES, SOME ON TWO SIDES, IN THE HANDWRITING OF JACK RUBY ON IDENTICAL NOTE PAPER MARKED "A"
2. SOME 8 PAGES, SOME ON TWO SIDES, IN THE HANDWRITING OF JACK RUBY ON NOTE PAPER APPROXIMATELY THE SAME SIZE AS PAPER MARKED "B"
3. SOME 6 TO 10 PAGES OF LARGE ADVERTISEMENT PAGES OF THE DALLAS TIMES HERALD. THESE WERE LONG AND LARGE AND BLANK WITH THE EXCEPTION OF THE FIRST PAGE WHICH HELD SOME 10 OF 12 NAMES. WHEN I ASKED "WHO WROTE THIS?" MISS TIMMONS EXPLAINED THAT THEY WERE TRANSCRIBED BY HER BECAUSE JACK RUBY HAD NOT BROUGHT THE DAY BOOK (LEDGER) HE PLANNED TO USE.

MR. KENNEDY IN ADDITION TO THE ABOVE I WAS TOLD THE 100 MEMBERSHIP CARDS WERE NOW IN THE MAIL GOING ON TO THE CATHOUSE CLUB OF JACK RUBY AND THAT THEY

WERE HIGHLY ATTRACTIVE, DONE IN PLASTIC AND SNAPPY. WHEN I ASKED WHO DID SUCH WORK I WAS SHOWN A CARD:

ETC.

IN MY CONVERSATION WITH THE STENOGRAPHER THE CONJECTURE RELATIVE TO A VISIT BY THE F. B. I. CAME UP AND I ASSURED HER THAT SHE WOULD HAVE A VISIT.

FROM A PARKING LOT DIRECT ACROSS FROM THE WHITE PLAZA HOTEL I DIALED THE F. B. I. RI 1-1211, IDENTIFIED MYSELF, AND ASKED FOR THEIR ADDRESS I THEN WENT TO FLOOR #12 AT 1114 COMMERCE ST. WHICH IS THE F. B. I.

HERE I WAS CORDIALLY MET BY A MR. NEELY AND I GAVE HIM THE FACTS OUTLINED IN THIS LETTER.

MISS TIMMONS TOLD ME IN OUR CONVERSATION: "FRANK WHEN I HEARD OF THE RUBY KILLING MY FIRST RE-ACTION WAS TO GOO AT THE MEMBERSHIP ROLL TO SEE IF OSWALD'S NAME WAS THERE, IT WAS NOT"

IN RESPECT TO YOU I FEEL THAT YOU WILL KNOW THAT THIS INFORMATION GIVEN TO

THE F. I. IN DALO'S AND THE  
DEPARTMENT OF JUSTICE IN WASH-  
INGTON, IS IN NO WAY AN EF-  
FORT ON MY PART TO REFLECT  
ON THE INTEGRITY OF THIS  
FINE WOMAN.
