SIGNED MERELY WITH INITIALS QUOTE ~~JHC~~ UNQUOTE. IN THE  
LETTER, WRITER STATES QUOTE DURING THE PAST SUMMER, A MEETING  
OF THE QUOTE /WITHIN/ FAIR PLAY UNQUOTE, WAS HELD AT  
RITTENHOUSE SQUARE, PHILADELPHIA AND SUGGESTS GUARDS OF  
FAIRMONT PARK WILL RECALL THIS MEETING. THE LETTER CONTINUES  
AS FOLLOWS -

QUOTE LEE WAS WITH US. I HAVE PICTURES OF THIS MEETING  
TO PROVE SUCH.

QUOTE LEE NEEDED SOME MONEY AND GOT SOME FROM A NIGHT  
CLUB PARTY CALLED QUOTE /WITHIN/ SPARKY UNQUOTE, IN DALLAS. SO  
HELP US IF RUBY SAYS HE DOES NOT KNOW US, HE LIES.

QUOTE A COPY OF THIS IS BEING GIVEN SECRET SERVICE,  
U.S. WE HAVE PHOTOGRAPHS TO PROVE SUCH. LEE WAS HERE THIS  
SUMMER AND KNOWS RUBY ENOUGH TO GET MONEY.

QUOTE /S/ JHC UNQUOTE.

NOTE RUEY KNOWN IN YOUTH BY NICKNAME SPARKY.
