MRS. MARIE STEPHENS FIVE SIX EIGHT HEDDEN AVE. AKRON, OHIO

INTERVIEWED ELEVEN TWENTY EIGHT SIXTY THREE AT HER REQUEST. SHE WAS
 GETTING OFF A BUS AT INTERSECTIONS OF MAIN AND MARKET STREET AKRON,
 OHIO, DIRECTLY IN FRONT OF PORTAGE HOTEL. ADVISED SHE OBSERVED TWO
 QUOTE CUBAN MALES UNQUOTE STANDING ALONE ON THE CORNER BY
 A QUOTE LATE NINETEEN SIXTY FOUR BUICK. UNQUOTE . ADVISED SHE KNEW
 IT WAS A NINETEEN SIXTY FOUR MODEL AS IT HAD QUOTE NEW WHITEWALLS
 TIRES AND HAD AN OHIO LICENSE NUMBER UNKNOWN UNQUOTE. CLAIMS SHE
 HEARD THE ONE MALE SAY TO HIS COMPANION QUOTE RUBY FOULED THINGS UP.
 WILL PICK UP EDDIE IN CHICAGO , HEAD FOR DALLAS AND MET CLARA AT THE
 CLUB. WE HAVE TO DO AWAY WITH RUBY BECAUSE HE FOULED THING UP. WHEN
 WE GET BACK TO CUBA CASTRO WILL GIVE US A MEDAL.

SHE DESCRIB^{ED} UNKNOWN MALES AS FIVE FEET SIX INCHES TO FIVE
 FEET EIGHT INCHES TALL, MEDIUM BUILD, DARK COMPLEXSION, BLACK HAIR,

SHIRTS.

SHE SAID THEY DID NOT MENTION NAME OF CLUB THEY WERE TO GO IN DALLAS BUT DID SAY QUOTE CLARA UNQUOTE WAS A STRIPTEASER AND ALSO REFERRED TO HER BY HER SPANISH NAME QUOTE CLARISA UNQUOTE. STEPHENS ALSO CLAIMS THAT JUST AFTER ASSASSINATION OF PRESIDENT KENNEDY SHE CALLED FBI WASHINGTON D.C. AND INFORMED THEM LEE OSWALD WOULD BE KILLED IF HE WAS NOT CLOSELY GUARDED. SHE SAID SHE GAVE FBI WASHINGTON THE DESCRIPTION OF THE AFOREMENTIONED TWO CUBANS. SHE WAS UNABLE TO GIVE LOGICAL EXPLANATION OF WHERE SHE SAW THEM PRIOR TO ELEVEN TWENTY EIGHT SIXTY THREE. STEPHENS ALSO CLAIMS SHE IS THE INDIVIDUAL WHO TYPED OF THE QUOTE HEAD OF THE FBI WASHINGTON D.C. UNQUOTE IN THE EARLY NINETEEN FIFTIES THAT AN ATTEMPT WOULD BE MADE BY PUERTO RICANS TO KILL FORMER PRESIDENT HARRY S. TRUMAN AT BLAIR HOUSE WASHINGTON D. C. SHE CLAIMS SHE IS RESPONSIBLE FOR TRUMAN NOT BEING KILLED AT THAT TIME. SHE SAID HER NAME IS ON FILE WITH FBI HEAD-QUARTERS FOR FURNISHING THIS INFORMATION. WHEN QUESTIONED AS TO HOW SHE KNEW THE TWO INDIVIDUALS SHE OBSERVED WERE CUBANS, STEPHEN RE-PLIED QUOTE CUBANS LOOK MORE STARVED THAN PUERTO RICANS UNQUOTE.
