ON DEC. FOUR INSTANT MARILYN PATRICIA JOYCE, NEE DE LONG, ONE ONE THREE TWO WEBBER DRIVE, LANSING, MICH., ADVISED SHE WAS EMPLOYED AS A HOSTESS BY BRANIFF AIRLINES WITH HEADQUARTERS AT DALLAS, TEXAS IN NINETEEN SIXTY AND SIXTYONE. DURING THIS PERIOD SHE RESIDED IN AN APARTMENT AT FOUR EIGHT ONE TWO ALCOT, DALLAS. EX.-III

SHE MET SUBJECT WHO ALSO HAD AN APARTMENT AT THIS ADDRESS AND AS A RESULT OF THIS MEETING VISITED THE SOVEREIGN CLUB LOCATED ON COMMERCE STREET IN THE COMPANY OF SEVERAL OTHERS AT RUBY/S INVITATION. SHE STATES SHE NEVER TALKED TO RUBY END PAGE ONE

ALONG, ALWAYS IN COMPANY OF OTHERS. SHE DESCRIBED RUBY AS A QUOTE GLAD HANDER UNQUOTE AND ONE WHO TRIED TO IMPRESS PEOPLE OF THE FACT THAT HE KNEW EVERYONE. SHE NEVER HEARD OF RUBY BEING ILL OR HAVING ANY MENTAL PROBLEMS. SHE HAS NO KNOWLEDGE OF HIS POLITICAL BELIEFS AND NEVER HEARD OF OSWALD PRIOR TO THE ASSASSINATION.

SHE HAS NO KNOWLEDGE OF RUBY BEING FRIENDLY WITH ANY DALLAS POLICE OFFICERS OR DALLAS CRIMINALS. SHE IS AWARE THAT RUBY SUPPOSEDLY OWNED THE VEGAS AND CAROUSEL CLUBS, HOWEVER, NEVER VISITED THEM.

SHE STATES THAT HER FORMER ROOMMATES WERE MANCY RITTS, NOW MRS. WILLIAM MC MILLAN, AND FRANCES WARLICK, NOW MRS. JAMES LEAK, BOTH RESIDING DALLAS, TEXAS. SHE STATES JAMES LEAK IS A QUOTE WEALTHY ATTORNEY AND GAMBLER WHO POSSIBLY KNOWS RUBY VERY WELL, UNQUOTE.
