THE FOLLOWING INDIVIDUALS WERE IDENTIFIED IN TELEVISION AND

ALL INDICATED SOME KNOWLEDGE OF RUBY-S ACTIVITIES, AND THE
FOLLOWING INFORMATION WAS DETERMINED THROUGH INTERVIEWS.

ALFRED DAVIDSON, HOLLYWOOD PARKWAY MOTEL, ONE ONE ZERO
THREE FOUR VENTURA BOULEVARD, NORTH HOLLYWOOD, CALIFORNIA,
ADVISED SA JOHN P. ANDREWS THAT HE HAS KNOWN RUBY SINCE LATE
SEPTEMBER OR EARLY OCTOBER, NINETEEN SIXTY THREE. HE WAS
BEFRIENDED BY RUBY AT THE CAROUSEL NIGHT CLUB WHILE DAVIDSON
WAS IN DALLAS ON BUSINESS. DAVIDSON CHARACTERIZED RUBY AS
BEING PERSON KNOWN TO EVERYONE. HE STATES RUBY KNOWS ALL OF
THE POLICE OFFICERS IN DALLAS, HAS A PRESS PASS ON HIS CAR

ALEXANDER P. GRUBER, FIVE TWO TWO TWO WEST OLYMPIC BOULEVARD, LOS ANGELES, CALIF., ADVISED SAS ROBERT K. BURESH AND VINCENT W. HUGHES THAT HE HAS KNOWN SUBJECT AS JAKE RUBENSTEIN SINCE GRAMMAR SCHOOL DAYS IN CHICAGO. HE SAW RUBY ABOUT TEN YEARS AGO AT THE SILVER SPUR CLUB IN DALLAS AND HIS NEXT CONTACT WITH RUBY WAS ABOUT TWO WEEKS AGO WHEN HE PASSED THROUGH DALLAS ON A TRIP BACK EAST.

GRUBER STATED HE RECEIVED A TELEPHONE CALL FROM RUBY ABOUT TWENTY MINUTES AFTER THE PRESIDENT HAD BEEN SHOT. RUBY ASKED QUOTE DID YOU HEAR WHAT HAPPENED.. UNQUOTE, AND GRUBER ANSWERED, QUOTE ABOUT THE PRESIDENT.. UNQUOTE. RUBY SAID QUOTE YES. AIN-T THAT A TERRIBLE THING. THAT REALLY GETS ME. MY SISTER IS HYSTERICAL. YOU DON-T KNOW THIS, AL, BUT I START ALL MY PROGRAMS WITH A PATRIOTIC NUMBER. UNQUOTE. GRUBER STATED RUBY THEN STARTED TO CRY AND RUBY THEN SAID,

GRUBER STATED HE HAD NO INFORMATION CONCERNING ANY CONNECTION ON RUBY-S PART WITH OSWALD OR THE FAIR PLAY FOR CUBA COMMITTEE, OR ANY INDICATION OF RADICAL OR EXTREMEIST VIEWS. HE KNOWS OF NO ACQUAINTANCES OF RUBY WITH DALLAS LAW ENFORCEMENT OFFICERS.

ON NOVEMBER TWENTYFIVE INSTANT, REAGAN/TURMAN, AKA BUDDY TURMAN, SEVEN TWO TWO ZERO HOLLYWOOD BOULEVARD, LOS ANGELES, *Calif.* A PROFESSIONAL BOXER, ADVISED SA LANFORD L. BLANTON THAT HE MET JACK RUBY IN DALLAS, TEXAS, ABOUT SIX OR SEVEN YEARS AGO. HAS WORKED FOR RUBY OFF AND ON FOR LAST FIVE YEARS. USUALLY MANAGED VEGAS CLUB, THREE FIVE ZERO EIGHT OAKLAWN AVENUE, DALLAS, FOR RUBY. LAST EMPLOYMENT FOR RUBY WAS JANUARY ONE LAST TO JULY NINETEEN SIXTY THREE. HE AND RUBY HAVE DATED AND QUOTE CHASED UNQUOTE GIRLS TOGETHER. HE SAYS CLOSEST ASSOCIATES OF RUBY ARE GEORGE SENATOR, RALPH PAUL, AND BILL HOWARD, ALL

OF DALLAS. PAUL BACKS SOME OF RUBY-S BUSINESS AND HOWARD HAS STORK CLUB, OAKLAWN AND CEDAR STREETS, DALLAS.

TURMAN SAYS THAT RUBY KNEW INTIMATELY NUMEROUS DALLAS, TEXAS POLICE OFFICERS. ONE NAME HE RECALLED WAS A LIEUTENANT GEORGE ARNETT OF DALLAS POLICE DEPARTMENT. TURMAN SAID HE WAS NOT SURPRISED AT RUBY SHOOTING OSWALD AND WAS NOT SURPRISED AT HIM BEING ABLE TO GET IN POLICE BUILDING AS HAD CONFIDENCE OF SO MANY OFFICERS. TURMAN SAYS RUBY AT LEAST CASUALLY ACQUAINTED WITH THE CHIEF OF POLICE AND OTHER HIGH OFFICERS.

TURMAN SAYS KNOWS RUBY AS A HIGHLY EMOTIONAL PERSON WHO LOSES ALL REASON WHEN BECOMES EXCITED.

IRVING KATZ, SIX ONE THREE NINE WEST SAN VICENTE, LOS ANGELES, CALIF. ADVISED SA GEORGE E. BLAND THAT HE KNEW JACK RUBY FROM NINETEEN FIFTY FIVE TO NINETEEN FIFTY NINE AT DALLAS, TEXAS, WHERE RUBY OWNED THE VEGAS CLUB AND KATZ WAS IN THE RECORD RECORDING AND DISTRIBUTING BUSINESS. RUBY WAS A LONELY MAN WHO BOUGHT FRIENDSHIP AND WAS AN EXTROVERT. HE CAME FROM

SOUTHSIDE OF CHICAGO FROM A POOR FAMILY. HE WAS FRIENDLY WITH OFFICERS OF THE DALLAS POLICE DEPARTMENT AND WAS A NAME DROPPER. IF HE LIKED YOU, HE WOULD DO ALMOST ANYTHING FOR YOU. HE HAD MANY LEGITIMATE FRIENDS. HE HABITUALLY CARRIED A GUN LIKE MANY PEOPLE IN DALLAS AND CARRIED MONEY FROM THE CLUB. HE COULD BE VIOLENT AND WAS KNOWN TO THROW PERSONS OUT OF THE CLUB BODILY. HE DID NOT HAVE A KILLER INSTINCT BUT ACTED ON IMPULSE. HE DESPISED HOODLUMS, COMMUNISTS AND SUPER AMERICANS. HE APPEARED TO BE A SINCERE, HONEST AMERICAN, AND RAN A PRETTY CLEAN OPERATION. HE HAD RE-EMBRACED JUDAISM AND WAS SEEN AT THE SYNAGOGUE AND APPEARED TO BE A RELIGIOUS PERSON.

MRS. IRVING KATZ, SAME ADDRESS, STATED SHE KNEW RUBY AS *100147*

QUICK TEMPERED, ANTI-COMMUNIST, BRAGGER, EGOMANIAC AND WELL ACQUAINTED WITH DALLAS POLICE, HOWEVER, SHE KNOWS OF NO SPECIFIC ACQUAINTANCES. HE ALSO ASSOCIATED WITH LOW CLASS PERSONS. HE LIVED WITH AN OLDER SISTER, WAS SINGLE, AND DID NOT DRINK OR SMOKE AND CLAIMED TO BE VERY RELIGIOUS.

JOE MEDILL, THREE TWO SIX THREE CASTLE HEIGHTS AVENUE, ADVISED SAA JOSEPH ARWINE THAT HE LAST SAW JACK RUBENSTEIN NINETEEN FORTY TWO IN CHICAGO. HE DOES NOT KNOW HIS POLITICAL BELIEFS, HAS NO INFORMATION THAT RUBENSTEIN WAS EVER CONNECTED WITH HOODLUMS, AND HAS NO INFORMATION REGARDING RUBENSTEIN-S POSSIBLE ASSOCIATION WITH DALLAS POLICE OFFICIALS.

IRVING ALKANA, TWO SIX ZERO THREE ONE EIGHTEENTH STREET, SAN BERNARDINO, CALIFORNIA, ADVISED SA CARL G. MURANO THAT HE WAS A RESIDENT OF DALLAS, TEXAS, FROM NINETEEN FORTY NINE TO NINETEEN FIFTY FIVE. HE PURCHASED CLUB VEGAS, DALLAS, IN NINETEEN FIFTY TWO OR NINETEEN FIFTY THREE. HE STATES HE MET JACK RUBY IN NINETEEN FIFTY TWO AND LATER SOLD RUBY ONE THIRD INTEREST IN CLUB VEGAS IN LEASE PURCHASE AGREEMENT. RUBY OPERATED THE CLUB TOGETHER WITH A CLOSE FRIEND, JOE BONDS, UNTIL SEPTEMBER NINETEEN FIFTY THREE WHEN ALKANA TOOK OVER MANAGEMENT OF CLUB. ALKANA STATES HE HAD NUMEROUS ARGUEMENTS

WITH RUBY, WHO WAS MAN OF VIOLENT TEMPER, FROM SEPTEMBER NINETEEN FIFTY THREE UNTIL JUNE NINETEEN FIFTYFOUR, AT WHICH TIME HE SOLD RUBY HIS COMPLETE TWO THIRDS INTEREST IN CLUB.

ALKANA STATES ON ONE OCCASION, APRIL OR MAY NINETEEN FIFTY THREE, HE HAD FIST FIGHT WITH RUBY AT CLUB VEGAS, AND RUBY SUBSEQUENTLY WAS ARRESTED AND BOOKED DALLAS CITY JAIL ON POSSIBLE CHARGE OF CARRYING CONCEALED WEAPON SINCE AT TIME OF FIGHT RUBY HAD THIRTY EIGHT SNUB NOSE REVOLVER IN HIS POSSESSION. STATED AFTER HE SOLD HIS INTEREST TO RUBY JUNE ONE NINETEEN FIFTY FOUR, HE SAW RUBY ON SEVERAL OCCASIONS BEFORE LEAVING DALLAS AREA NINETEEN FIFTY FIVE. STATES HAS SEEN RUBY ONLY ONCE SINCE NINETEEN FIFTY FIVE, THAT BEING ON A VISIT HE MADE TO DALLAS IN NINETEEN SIXTY.

ALKANA STATES RUBY IS VERY EMOTIONAL AND UNSTABLE INDIVIDUAL WHO ALWAYS CARRIED A PISTOL SINCE HE, RUBY, CLAIMED HE CARRIED LARGE SUMS OF MONEY. ALSO, RUBY SEEMED TO KNOW

EVERY POLICEMAN IN DALLAS AND PARTICULARLY EVERY IMPORTANT OFFICIAL AND NEWSPAPERMAN IN THE CITY.

ALKANA STATES THAT ONE ON OCCASSION RUBY MENTIONED A SISTER AND A BROTHER WHOSE NAMES ALKANA CANNOT NOW RECALL, BUT THAT NE NEVER MET ANY OF RUBY-S FAMILY. STATES RUBY HAD A GIRL FRIEND NAMED ALICE LNU DURNING PERIOD APPROXIMATELY NINETEEN FIFTY THREE TO NINETEEN FIFTY FIVE. ALKANA CANNOT FURNISH ANY FURTHER INFORMATION CONCERNING ALICE. ALKANA STATES THAT HE DOES NOT KNOW NAMES OF ANY SPECIFIC POLICE OFFICERS, NEWSPAPERMEN OR OFFICIALS WITH WHOM RUBY HAD CLOSE ASSOCIATION.

ALKANA STATES HE NEVER SAW LEE HARVEY OSWALD AND DOES NOT KNOW ANY CONNECTION WHICH RUBY MIGHT HAVE HAD WITH OSWALD. STATES DOES NOT KNOW OF ANY POLITICAL ACTIVITY ON PART OF RUBY AND KNOWS OF NO ONFORMATION CONCERNING FAIR PLAY FOR CUBA COMMITTEE, OR IN FACT ANY OTHER POLITICAL ORGANIZATION IN DALLAS. ALKANA STATES THAT RUBY INTIMATED THAT HE HAD CONTACTS WITH UNDERWORLD FIGURES BUT ALKANA STATES

STILL LOCATED IN DALLAS.

WELDON MORGAN, ONE EIGHT THREE SEVEN NORTH GRAMERCY
PLACE, APARTMENT TWO NINE, LOS ANGELES, ADVISED SAA JOSEPH
A. ARWINE THAT HE RESIDED IN DALLAS, TEXAS, FOR PAST
TWENTYFIVE YEARS AND MET JACK RUBY IN NINETEEN FIFTYNINE
EARLY NINETEEN SIXTY AT THE VEGAS CLUB. FROM NINETEEN SIXTY
UNTIL AUGUST NINETEEN SIXTYTWO, HE VISITED THE VEGAS CLUB
APPROXIMATELY TWO OR THREE TIMES A MONTH. HE HAS NEVER SEEN
RUBY IN COMPANY OF POLICE OFFICERS AND HAS NO DEROGATORY
INFORMATION REGARDING HIM. STATED RUBY HAD NUMEROUS
CUSTOMERS WHO HAD BEEN ARRESTED FOR PETTY OFFENSES IN

DALLAS. MORGAN DOES NOT KNOW LEE HARVEY OSWALD AND HAS NO PERSONAL KNOWLEDGE CONCERNING RUBY-S BACKGROUND.

MR. ALBERT DUNN, ONE FIVE FOUR NORTH ARNAZ DRIVE, ILL. BEVERLY HILLS, CALIFORNIA, ADVISED SAS ROBERT K. BURESH AND VINCENT W HUGHES TODAY HE GREW UP IN THE SAME NEIGHBORHOOD WITH JACK RUBY IN CHICAGO. HE STATED RUBY-S MOTHER QUOTE WAS SEVENTY FIVE PER CENT INSANE UNQUOTE AND WAS IN AND OUT OF MENTAL INSTITUTIONS AS A YOUNG WOMAN. HE STATED RUBY-S FATHER DRANK TOO MUCH. AS A RESULT OF THIS BAD ENVIRONMENT, RUBY AS A BOY LIVED IN PRIVATE HOMES OTHER THAN HIS OWN, AND THIS MAY HAVE BEEN FINANCED BY CHICAGO SOCIAL SERVICES.

DUNN STATED HE LIVED WITH RUBY IN SAN FRANCISCO FOR ALMOST TWO YEARS MANY YEARS AGO. HE DID NOT SEE ANY DISPLAY OF MENTAL INSTABILITY EXCEPT FOR FLASHES OF TEMPER AND MINOR PECULIARITIES. DUNN SPECULATED THAT WITH THE RECORD OF INSANITY IN RUBY-S FAMILY, THAT THE INCIDENT OF THE PRESIDENT BEING SHOT QUOTE TRIGGERED UNQUOTE THIS INSTABILITY IN RUBY

FURTHER, SOLL WAS UNABLE TO FURNISH THE IDENTITY OF ANY PERSONS, EITHER IN THIS AREA OR ELSEWHERE, WHO COULD FURNISH ANY INFORMATION CONCERNING RUBY.

IT IS TO BE NOTED THAT SOLL WAS INTERVIEWED ON ONE OF THE LOCAL TV STATIONS AT LOS ANGELES ON NOVEMBER TWENTY FOUR LAST, AT THIS TIME HE DESCRIBED RUBY AS A LONG TIME ACQUAINTANCE AND STATED THAT IN CONNECTION WITH HIS BUSINESS OPERATION, SOLL BAIL BONDS, FOUR FIVE ZERO NINE WEST PICO BOULEVARD, HE HAD SOLICITED THE AID OF OTHER ACQUAINTANCES OF RUBY IN THE

SHE STATED THEY CAN BE REACHED CARE OF VIA VIDA, AFRICAN MERCANTILE COMPANY, MERCANTILE HOUSE, POST OFFICE BOX ONE ONE ZERO, MOMBASA, KENYA, EAST AFRICA.
