[REDACTED] LOUISVILLE, KY., HAS ADVISED THAT GENERAL ELECTRIC COMPANY, LOUISVILLE, KY., IN OCTOBER HAD A GROUP OF ENTERTAINERS STAYING AT BROWN SUBURAN MOTEL WHERE [REDACTED] THINKS TWO ENTERTAINERS, BETTY RHODES, DANCER-SINGER, AND LOU CUTLET, COMEDIAN HAD BOOKS ON COMMUNISM-MARKISM ALTHOUGH SHE IS VAGUE AS TO BASIS OF HER OPINION. STATES ALSO THAT THEY PAREN MEMBERS OF THE GROUP OF ENTERTAINERS PAREN TOLD HER THAT THEY HAD JUST COME FROM JACK RUBY-S CAROUSEL CLUB IN DALLAS. DOES NOT KNOW WHO TOLD HER OR WHO OR HOW MANY GROUP WERE SUPPOSED TO HAVE WORKED CAROUSEL. JEAN FOOTE, SALES RELATIONS GE, LOUISVILLE, KY., ADVISED THAT ENTERTAINERS WERE APPEARING IN SHOWS AT GENERAL ELECTRIC PLANT, LOUISVILLE, SEPTEMBER AND OCTOBER IN CONNECTION WITH INTRODUCTION OF NEW MODEL APPLIANCES TO DEALERS AND DISTRIBUTORS.

SHOW PRODUCED BY DRAMATURGY, INC., TWO THREE ZERO SEVEN CHESTER AVE CLEVELAND, OHIO. DRAMATURGY BELIEVED TO BE OWNED BY MAN NAMED FNU WILDE C. RANKIN BINGHAM IS PRESIDENT OF DRAMATURGY, FRANK WARRINGTON WAS DIRECTOR OF THE GE PRODUCTION.
