AND COMPANY HANDLED RUBY-S BOOKS AND TAX RETURNS FROM
NINETEEN FIFTY SEVEN OR FIFTY EIGHT UNTIL LATE NINETEEN
FIFTY NINE OR SIXTY. MRS. ~~REX~~ MRS RITA SMRAKA, WHO HANDLED RUBY-S
ACCOUNT FOR W. BOONE GOOD AND COMPANY WAS FIRED ON THE
LATTER DATE AND TOOK RUBY-S ACCOUNT WITH HER. AT THE
TIME RUBY HAD ONLY THE VEGAS CLUB. WATTERS ADVISED HE
DID NOT KNOW RUBY SOCIALLY BUT ONLY ON A BUSINESS BASIS.
WATTERS STATED DURING PERIOD RUBY-S ANNUAL INCOME WAS
BETWEEN TWO THOUSAND DOLLARS AND TEN THOUSAND DOLLARS.

WHEN QUESTIONED BY WATTERS AS TO ADDITIONAL INCOME, RUBY STATED HE RECEIVED SOME FINANCIAL AID FROM HIS BROTHER, NAME UNKNOWN AND AMOUNT NOT SPECIFIED. WATTERS CONSIDERS RUBY A QUOTE LONE WOLF UNQUOTE AND KNEW OF NO ASSOCIATES. HOWEVER, ON ONE OCCASION RUBY TOLD WATTERS OR SMRAKA, WHO TOLD WATTERS, THAT RUBY WAS DATING THE SECRETARY OF A PROMINENT DALLAS MAN. WATTERS CANNOT REMEMBER NAME OF GIRL OR HER EMPLOYER. RUBY WAS VERY NEAT AND CLEAN AND VERY SENSITIVE ABOUT HIS PERSONAL APPEARANCE, ALMOST TO POINT OF BEING EFFEMINATE, ALTHOUGH BASICALLY VERY HARD AND TOUGH. RUBY WAS NEVER KNOWN TO EXPRESS POLITICAL OPINIONS. WATTERS ADVISED HE FOUND RUBY TO BE VERY PLEASANT AND CONGENIAL BUT ALSO VERY NERVOUS AND JUMPY AND HIGH STRUNG. RUBY DID NOT APPEAR TO BE LIVING BEYOND HIS INCOME AND HAD A MODEST APARTMENT AND DROVE AN OLD MODEL BUICK. WATTERS ADVISED THAT RITA SMRAKA WAS CLOSER TO RUBY THAN ANYONE ELSE IN THE FIRM AND COULD BE LOCATED THROUGH MRS. CATHY MC FARLAND, A SECRETARY AT THE DALLAS OFFICE OF ALEXANDER GRANT AND COMPANY, TWO ONE ZERO ZERO FIDELITY UNION TOWER.
