SMITH. BROSSAU STATED CALL FROM DALLAS WAS RECEIVED BY MIKE SHORE WHO WAS IN HIS OFFICE ON OCT. TWO FIVE LAST. BROSSAU ADVISED HE IS DIRECTOR, CURTIS ENTERPRISES, WHICH IS NEW BRANCH OF CURTIS PUBLISHING CO. TO HANDLE DIVERSIFICATION OF BUSINESS AND JOINT VENTURES. HE ADVISED DURING PAST SUMMER VIA INTEROFFICE MEMO HE BECAME AWARE OF RECORD ALBUM PROMOTION WHICH APPEARED TO HAVE GOOD MONEY MAKING POTENTIAL. HE ADVISED ANOTHER DEPARTMENT OF CURTIS HAD BECOME AWARE OF THIS AT A PREMIUM CONVENTION. MEMO SET OUT THAT SHOULD ANYONE BE INTERESTED MIKE SHORE SHOULD BE CONTACTED AND HIS ADDRESS WAS GIVEN. HE STATED HE CALLED SHORE IN LOS ANGELES AND OFFERED AN EXCLUSIVE HANDLING OF SALES OF ALBUMS THROUGH CURTIS ENTERPRISES. SHORE WAS INTERESTED AND AFTER CONSULTING WITH FRANK SINATRA AND OTHER DIRECTORS OF REPRIZE RECORDS IN LOS ANGELES, AND SEVERAL SUBSEQUENT PHONE CALLS TO AND FROM BROSSAU IN NEW YORK, A MEETING WAS HELD BETWEEN BROSSAU AND SHORE IN NEW YORK ON OCT. TWO AND THREE SIXTYTHREE. DETAILS OF ARRANGEMENTS WERE MADE BETWEEN

BROSSEAU AND SHORE FROM THE ABOVE DATES TO OCT. TWO FIVE LAST, OCCASION OF THEIR LAST MEETING, WHICH WAS HELD IN PHILA AT WHICH TIME ADVERTISING FORMATS, FINAL CONTRACT ARRANGEMENTS AND OTHER DETAILS OF PROMOTION WERE WORKED OUT. MEETING WAS TRANSFERRED TO NEW YORK ON SATURDAY, OCT. TWO SIX, AND CONTINUED THERE UNTIL APPROX TUESDAY, OCT. TWO NINE LAST, LAST PHYSICAL MEETING BROSSEAU HAD WITH SHORE.

REPRISE RECORDS IS A FRANK SINATRA ENTERPRISE, WHICH HAS RECENTLY BEEN PURCHASED BY WARNER BROS. BROSSEAU UNAWARE OF SHORE/S STATUS IN COMPANY.

SINCE OCT. TWO FIVE BROSSEAU AND SHORE HAVE CONTINUED PHONE CONTACT. BROSSEAU ADVISED SATURDAY NOV. THIRTY LAST, SHORE PHONED HIM, INQUIRING IF CURTIS INTERESTED IN JACK RUBY/S EXCLUSIVE STORY. SHORE EXPLAINED HE GREW UP IN CHICAGO WITH EARL RUBY. HE ADVISED EARL, CURRENTLY A RESIDENT OF DETROIT, PRESENTLY IN DALLAS TO ASSIST JACK

RUBY AND THINKING SHORE HAD CONTACTS IN PUBLISHING BUSINESS ADVISED SHORE HE COULD THROW STORY TO FRIEND OR ASSOCIATE OF SHORE.
