POLYGRAPH EXAMINATION REPORT.

NANCY ELAINE PERRIN GIVEN POLYGRAPH EXAMINATION DECEMBER FIVE INSTANT, OAKLAND, CALIFORNIA, BY SA DAVID E. TODD. SA WILLIAM N. KIDWELL, JR. PRESENT DURING EXAMINATION. PERRIN IS WHITE FEMALE, THIRTYFIVE YEARS OLD. SHE STATED ATTEMPTED SUICIDE NINETEEN FIFTYSIX, FOLLOWING WHICH VOLUNTARILY COMMITTED SELF TO PSYCHIATRIC WARD NORTH HAMPTON STATE HOSPITAL, MASSACHUSETTS. DISCHARGED AFTER TEN DAYS OBSERVATION.

ARRESTED DENVER NINETEEN SIXTY FOR CARRYING CONCEALED WEAPON, TWENTYFIVE DOLLAR FINE., ARRESTED BOSTON NINETEEN SIXTY OR NINETEEN SIXTYONE FOR PROSTITUTION, TWO HUNDRED DOLLAR FINE., ARRESTED DALLAS TWICE SUMMER SIXTYONE FOR PROSTITUTION, CHARGES REDUCED TO VAGRANCY.

HAS SUFFERED FROM CHOREA PAREN ST. VITUS DANCE ENDPAREN, SINCE AGE EIGHT. EXTREMELY NERVOUS. CURRENTLY UNDER PHYSICIANS CARE FOR LOW BLOOD PRESSURE. TAKING METHEDRINE. TOOK TEN MILLIGRAMS TODAY.

STATES WORKED AS PROSTITUTE BEGINNING LATE SIXTY. CLAIMS WAS ASSOCIATED IN DENVER IN SIXTY WITH QUOTE YOUNG ENDQUOTE ANTHONY QUOTE PIGGY END QUOTE MARCHESE PAREN PHONETIC ENDPAREN, DESCRIBED AS SYNDICATE MAN FROM NEW YORK, THEN HIDING OUT IN DENVER, AND SHE ACTED AS HOSTESS AT SYNDICATE PARTIES. SAID BY SYNDICATE SHE MEANS ITALIAN QUOTE MAFIA ENDQUOTE HEADED BY VITO GENOVESE OF ITALY, AND THAT SHE LEARNED THIS FROM ENTERTAINING MARCHESE AND OTHER SYNDICATE MEN, NAMES UNKNOWN TO HER, IN DENVER. STATED IN SUMMER SIXTYONE, MARCHESE CONTACTED JACK RUBY IN DALLAS WHILE SHE WAS WORKING AT CAROUSEL CLUB AND MARCHESE HIRED HER TO DEAL CARDS IN CARDGAME AT QUOTE TOP ENDQUOTE DALLAS HOTEL ON COMMERCE STREET WHERE TWO BUSINESSMEN WHOM SHE REFUSED TO NAME LOST SUBSTANTIAL MONEY, AND SHE WAS PAID EIGHT HUNDRED DOLLARS BY MARCHESE FOR THIS. MARCHESE TRIED TO PERSUADE HER TO GO TO LAS VEGAS AND GET A JOB WITH LOU BRINDISI, DEALER, SILVER SLIPPER, LAS VEGAS, BUT SHE REFUSED. SHE HAD BRINDISI-S CALLING CARD IN HER POSSESSION. STATED SHE WORKED FOR RUBY AT THE CAROUSEL CLUB FIVE WEEKS IN SUMMER OF SIXTYONE AND QUIT FOLLOWING QUARREL AND FIGHT WITH RUBY IN WHICH HE PUSHED HER AGAINST A CASH REGISTER AND THREATENED TO THROW HER DOWN THE STAIRS. SHE SAID SHE DISLIKED RUBY. SHE WAS REINTERVIEWED ABOUT MEETINGS CONCERNING CUBAN ARMS AND STORY VARYS FROM THAT

ORIGINALLY FURNISHED. SHE SAID THERE WERE ONLY THREE MEETINGS. FIRST MEETING OCCURRED SUBSEQUENT TO HER EMPLOYMENT AT CAROUSEL CLUB. SHE AND HUSBAND INTRODUCED BY ONE QUOTE DICK C. ENDQUOTE, BARTENDER, UNIVERSITY CLUB, DALLAS, TO UNKNOWN ARMY COLONEL AT COLONEL-S APARTMENT, ADDRESS UNKNOWN, WHO PROPOSED THAT HER HUSBAND PILOT BOAT TO CUBA TO BRING REFUGEES BACK TO U.S. FOR TWENTY THOUSAND DOLLARS. VAGUE REFERENCE AT THIS MEETING MADE TO ENFIELD RIFLES WHICH SHE DID NOT FULLY UNDERSTAND AT TIME. PROPOSAL NOT ACCEPTED, BUT THEY AGREED TO ATTEND SECOND MEETING. SECOND MEETING AT SAME PLACE. ABOUT TWELVE PERSONS PRESENT, INCLUDING RUBY, NAMES OF OTHERS UNKNOWN. ONE REFERRED TO AS QUOTE PETE END QUOTE. AT THIS MEETING SHE LEARNED PLAN ALSO INCLUDED DELIVERING ENFIELD RIFLES AND OTHER ARMS TO CASTRO FORCES. SHE PROTESTED THIS, BUT STILL AGREED TO ATTEND ANOTHER MEETING. THE THIRD MEETING IN SAME PLACE. ABOUT SEVEN PEOPLE PRESENT, INCLUDING RUBY. STATES AT THIS MEETING SHE REFUSED TO HAVE ANY MORE TO DO WITH THIS PLAN. SHE STATED JUST PRIOR TO THIS MEETING, AN UNKNOWN MAN FROM CHICAGO NAMED QUOTE NICK ENDQUOTE CONTACTED RUBY AT CAROUSEL CLUB WHERE SHE WAS THEN EMPLOYED, AND RUBY CAUGHT HER LISTENING AT KEYHOLE, WHICH WAS CAUSE OF QUARREL RESULTING IN HER DISCHARGE FROM CLUB. THIS IN CONFLICT WITH PRIOR STATEMENT THAT ALL MEETINGS OCCURRED AFTER SHE RESIGNED FROM CAROUSEL CLUB.

HISTORY AND USE OF DRUGS, HOWEVER, SIGNIFICANT EMOTIONAL RESPONSES RECORDED BY POLYGRAPH LEAD EXAMINER TO BELIEVE HER STORY CONCERNING THE CUBAN ARMS MEETINGS IS UNTRUE. THE EXAMINER IS OF OPINION SHE HAS TENDENCY TO DELUSIONS OF GRANDEUR. DURING INTERVIEW SHE CLAIMED ACQUAINTANCE WITH MRS. JACQUELINE KENNEDY PRIOR TO HER MARRIAGE. ALSO CLAIMS SHE KNEW AND HAD DANCED WITH SENATOR EDWARD KENNEDY DURING HIS ATTENDANCE AT HARVARD AND CLAIMS SHE WAS EMPLOYED AS LOBBYIST FOR LIQUOR INTERESTS AT MASSACHUSETTS LEGISLATURE IN NINETEEN SIXTY. EXAMINER CANNOT EVALUATE WHAT PORTION OF ANY OF HER STORY IS TRUE.

SUGGEST INQUIRIES BE MADE TO DETERMINE IF PIGGY MARCHESE EXISTS AND IF SO INTERVIEW HIM. MARCHESE DESCRIBED AS QUOTE BIG FAT SLOPPY FELLOW ENDQUOTE. CONCERNING EDDY MARKS, SHE SAID HE IS OWNER ~~OF~~ OR BROTHER OF OWNER, LITTLE NERO CLUB, DEBOLIVA STREET, EAST ST. LOUIS, OWNER RACE HORSE STABLE. WHITE MALE, FORTY YEARS, FIVE NINE IN HEIGHT, MEDIUM BUILD, DARK COMPLEXION, BLACK HAIR, ITALIAN APPEARANCE.

STATES HAS NO INFORMATION CONCERNING OSWALD., HAD NEVER SEEN HIM OR MET HIM AND NEVER HEARD RUBY MENTION OSWALD. ALSO STATES ENTERTAINER BUDDY KING KNEW RUBY AND SHE THINKS KING HAD SOMETHING ON RUBY.

LAS VEGAS INTERVIEW LOU BRINDISI CONCERNING MARCHESE-S WHEREABOUTS AND SET OUT LEAD TO INTERVIEW HIM.
