REBUTEL NOVEMBER TWENTYNINE LAST. ANONYMOUS THREAT TO UNIDENTIFIED BUSINESSMAN.

SETH KANTOR, PRESS WASHINGTON CORRESPONDENT, SCRIPPS-HOWARD NEWSPAPER, DALLAS, ADVISES INFORMATION IN REFERENCED COMMUNICATION OBTAINED BY HIM FROM C.A. QUOTE PAPPY UNQUOTE DOLSEN.

C.A. QUOTE PAPPY UNQUOTE DOLSEN, BOOKING AGENT FOR ENTERTAINING ARTISTS, DALLAS, TODAY ADVISES HE HAD TALK WITH SETH KANTOR, A NEWSPAPER REPORTER, AND HAD INFORMED HIM THAT HE DID NOT WANT ANY PUBLICITY, AND KANTOR APPEARED TO QUOTE JUST WANT A STORY UNQUOTE. DOLSEN ADVISED HE HAS RECEIVED THREE ANONYMOUS TELEPHONE CALLS LOCALLY, DATES NOT RECALLED, ONE HAVING BEEN RECEIVED AT HIS HOME AND TWO AT BUSINESS. MALE VOICE WHICH HE DID NOT RECOGNIZE ADVISED QUOTE IF YOU KNOW WHATS GOOD FOR YOU, YOU WILL STAY AWAY FROM THE COURT HOUSE UNQUOTE. THE CALLER DID NOT MENTION RUBY BY NAME BUT SAID QUOTE DON-T YOU TALK ABOUT IT UNQUOTE. DOLSEN SAID HE HAS NOT AT ANY TIME RECEIVED ANY THREATS AGAINST EITHER HIS LIFE OR THAT OF HIS WIFE AND HAS DISMISSED THESE CALLS AS QUOTE CRANK UNQUOTE CALLS. HE INFORMED IN HIS BUSINESS HE HAS RECEIVED MANY

CRANK CALLS IN THE PAST AND HAS NOT PAID ANY ATTENTION TO THEM AND DOES NOT IN THIS CASE. DURING THE TELEPHONE CALLS RECEIVED, TWO OF WHICH APPARENTLY WERE MADE BY THE SAME INDIVIDUAL, NO MENTION WAS MADE OF WAGGONER, ~~CARR~~ AND IN HIS CONVERSATION WITH SETH KANTOR, DOLSEN DID NOT MENTION THAT NAME.

DOLSEN ADVISES THAT HE IS WELL ACQUAINTED WITH JACK RUBY BUT HAS NO REASON TO BELIEVE HE WOULD EVER BE CALLED UPON TO TESTIFY IN THIS CASE AGAINST RUBY.

DOLSEN ADVISED THAT HE HAS NO SUSPECTS IN THIS CASE REGARDING THE ANONYMOUS PHONE CALLS.
