JACK LEON RUBY, AKA., LEE HARVEY OSWALD DASH VICTIM, CR. OO...DALLAS.

[REDACTED], ATTORNEY, AND MEMBER OF THE FIRM [REDACTED]

[REDACTED] CRIMINAL ATTORNEY, CHICAGO, ILLINOIS, ADVISED THAT HE RECALLED JACK LEON RUBY, WHOM HE KNEW AS SPARKEY. HE ADVISED THAT RUBY WAS A QUOTE HANGERON UNQUOTE AND A TICKET SCALPER AT THE VARIOUS BALL PARKS AT CHICAGO. [REDACTED] ADVISED RUBY NEVER CONNECTED WITH ANY PROMINENT INDIVIDUALS IN THE HOODLUM ELEMENT. RUBY WAS THE TYPE OF INDIVIDUAL WHO HAD A HOT TEMPER AND LIKED TO ASSOCIATE WITH INDIVIDUALS OF PROMINENCE, ALTHOUGH HE WAS NEVER ABLE TO SUCCESSFULLY CULTIVATE THEIR FRIENDSHIP. [REDACTED] DESCRIBED RUBY AS A QUOTE NOTHING. UNQUOTE.

[REDACTED] FURTHER ADVISED THAT ABOUT EIGHTEEN TO TWENTY YEARS AGO HE SEEMED TO RECALL THAT RUBY WAS ARRESTED FOR RAPE IN CHICAGO, AND WAS EVENTUALLY FOUND NOT GUILTY AFTER A TRIAL. HE ADVISED THAT AN INDIVIDUAL WHOSE NAME HE BELIEVED WAS VINCE QUOTE SNEAKY UNQUOTE HEALY, WAS THE CODEFENDANT WITH RUBY IN THE RAPE CASE, AND WAS ALSO FOUND NOT GUILTY. [REDACTED] COULD NOT REMEMBER SPECIFICS REGARDING THIS
