INVESTIGATION THIS DATE BY RESIDENT AGENT, BILOXI, MISS. HAS
RESULTED IN DETERMINING THAT AN INDIVIDUAL KNOWN AS ANDREW RAMEUSH,
POSSIBLY THE QUOTE ANDY UNOOTE REFERRED TO IN RE TELETYPE FROM
JACKSONVILLE PRESENTLY OPERATES THE SHO BAR ON THE MISSISSIPPI
GULF COAST. RAMEUSH NOT AT THE SHO DASH CLUB OR AT HIS PLACE OF
RESIDENCE AT THIS TIME. HOWEVER, ARRANGEMENT HAVE BEEN MADE FOR HIM
TO CONTACT BILOXI RESIDENT AGENT SOME TIME THIS WEEKEND, AT WHICH

MR. GIOVANNI QUOTE SAM UNQUOTE~~URATTA~~, OWNER AND OPERATOR BRUNINGS RESTAURANT, METAIRIE, LA., INFORMED THAT HE WAS INTERVIEWED BY NEWSPAPER REPORTER FOR DUBUQUE, IOWA, TELEGRAPH HERALD ON OR ABOUT THANKSGIVING DAY, TO WHOM HE STATED HE THOUGHT PHOTOGRAPHS OF BOTH JACK RUBY AND LEE HARVEY OSWALD WERE FAMILIAR TO HIM. HE STATED HE BELIEVED ONE OR BOTH OF THESE INDIVIDUALS HAD BEEN IN HIS RESTAURANT ON POSSIBLY ONE OR MORE OCCASIONS DURING SUMMER OF NINETEEN SIXTYTHREE.

HE STATED THAT IT WAS POSSIBLE THAT HE WAS MISTAKEN AND FURTHER COULD NOT STATE DEFINITELY ONE WAY OR ANOTHER AS TO WHETHER THE TWO INDIVIDUALS HE THOUGHT MIGHT BE IDENTICAL WITH OSWALD OR RUBY WERE IN HIS PLACE TOGETHER.

HE STATED THAT IN VIEW OF THE VOLUME OF CUSTOMERS IN HIS RESTAURANT, HE VERY WELL COULD HAVE BEEN MISTAKEN BUT FELT THAT THERE WAS A FAMILIARITY ABOUT THE PHOTOGRAPHS OF BOTH INDIVIDUALS.
