OR ACTIVITIES.

MEMBER OF AGVA, NYC, ADVISED SAS EDWARD S. LEMMAN AND JAMES H. BEARDSLEY  
HE NEVER KNEW RUBY PERSONALLY AND COULD PROVIDE NO INFORMATION CONCERNING  
HIS ACTIVITIES OR BACKGROUND.

THIRTEEN TWELVE AND ONE-HALF COMMERCE ST. DALLAS. FAYE STATED RUBY
