PERRIN HAS NERVOUS DISORDER /ST. VITUS DANCE/, WHICH SHE FEELS MAY  
AFFECT PLXXX POLYGRAPH, BUT IS WILLING TO TRY. PERRIN FURNISHED TWO  
TELEPHONE NUMBERS FROM HER ADDRESS BOOK, WHICH SHE SAID ARE NUMBERS IN  
DALLAS. SHE CANNOT REMEMBER WHO THEY BELONG TO AND SAID THEY MIGHT BE

[PERRIN] SAID HER DECEASED HUSBAND, [ROBERT PERRIN,] WAS ALSO KNOWN AS [JACK STARR IN HIS AUTO THRILL SHOW " JACK STARR-S SPILLS AND CHILLS."] HE ALSO WORKED FOR [SITTONS AUTO CENTER, ONE SIX TWO NINE EAST MAIN,] GRAND PRAIRIE, TEXAS, [TELEPHONE AN TWO - ONE SIX THREE ONE,] WHICH [NANCY PERRIN] BELIEVES IS AUTO BUSINESS NOW. [NANCY PERRIN] IDENTIFIES DICK, LAST NAME BEGINS WITH C, BUT CANNOT BE REMEMBERED BY [PERRIN] DICK C-S HOME PHONE IS TA FOUR - ZERO EIGHT FIVE SIX. DICK C IS A BARTENDER AT THE UNIVERSITY CLUB ON COMMERCE STREET, DALLAS. DICK C WAS [PERRIN-S] CONTACT IN CALL GIRL OPERATION AND IS THE ONE THAT TOOK [PERRIN] AND HER HUSBAND TO CUBAN GUNRUNNING MEETING THE FIRST TIME AND WAS PRESENT AT SECOND MEETING WHEN RUBY ALSO ATTENDED.

[NANCY PERRIN] ALSO RESIDED AT [FOUR EIGHT ZERO THREE JUNIUS,] DALLAS, AND HAS A DALLAS PUBLIC LIBRARY CARD, EXPIRATION DATE SEPTEMBER FIFTEEN, NEXT, WITH REFERENCE [P.T. RAYBURN, SIX TWO THREE FIVE SARATOGA,] DALLAS. [RAYBURN] IS DALLAS POLICE OFFICER, [TELEPHONE TA SEVEN - SIX FIVE THREE EIGHT] SHE SAID SHE ALSO LIVED ON [LIVE OAK] IN DALLAS, ADDRESS NUMBER FORGOTTEN.

"HAYWARD, CALIFORNIA

"I, [NANCY ELAINE PERRIN,] VOLUNTARY FURNISH THE FOLLOWING STATEMENT TO RICHARD G. ALLEN AND PHILIP NOTTINGHAM, WHO HAVE IDENTIFIED THEMSELVES TO ME AS SPECIAL AGENTS OF THE FEDERAL BUREAU OF INVESTIGATION. I WAS BORN IN [PORTSMOUTH, HXXXNEW HAMPSHIRE, ON SEPTEMBER NINE , NINETEEN THIRTYSIX, AS BARBARA JEAN ZIEDMAN] AND ADOPTED AT AGE EIGHT MONTHS BY [LAWRENCE MATHEWS AND HELEN MATHEWS.] I WAS KNOWN AS [NANCY ELAINE MATHEWS] I LIVED IN DALLAS IN NINETEEN SIXTYONE WHEN I WAS MARRIED TO [ROBERT PERRIN.] I WORKED IN THE CAROUSEL FOR JACK RUBY AS A WAITRESS AND BARTENDER DURING JULY AND POSSIBLY IN AUGUST NINETEEN SIXTY ONE. SOMETIME BETWEEN AUGUST AND NOVEMBER NINETEEN SIXTYONE, MY HUSBAND [ROBERT PERRIN] CAME HOME AND SAID HOW WOULD YOU LIKE TO MAKE SOME BIG MONEY BY ATTENDING A MEETING TONIGHT QUESTION MARK I SAID SURE. I AM ALMOST NINETY-NINE PER CENT SURE THAT A CONTACT OF MINE AT THE UNIVERSITY CLUB THAT I CAN REMEMBER ONLY AS DICK., HIS LAST NAME BEGINS C., HIS HOME PHONE WAS POSSIBLY TA FOUR - ZERO EIGHT FIVE

SIX., DICK TOOK MY HUSBAND AND ME AND ANOTHER GIRL HUSTLER FOR DICK, TO THIS FIRST MEETING. IT WAS A MEETING FOR INTRODUCTION PURPOSES ONLY. THE NEXT MEETING WEE JUST MY HUSBAND AND I WENT ALONE IN OUR CAR.
