The following additional points are being brought to your attention subsequent to a review of rerep in the event these items have not to date been resolved.

Joe Bonds, an inmate, Texas Department of Corrections, Huntsville, Texas, and an associate of the subject, advised the subject gave some police officers off-duty paying jobs in his clubs. Bonds should be reinterviewed and this specific point elaborated upon in an attempt to ascertain the identity of particular police officers who according to Bonds were in the employ of the subject on off-duty hours. These officers should then immediately be interviewed.

Interviews with police and other pertinent persons should include, but not be limited to determining whether the person interviewed or any close friend of Ruby's was a member of the police security detail on 11/24/63 and whether he has any knowledge of how Ruby gained access to the basement bearing in mind the possibility that Ruby may have been knowingly permitted to enter by a friendly officer.

Known associates of the subject, such as Joe Slaton,

Should be interviewed.

Joyce Lee Witherspoon McDonald, an exotic dancer employed by subject, advised Detective Bob Carroll of the Dallas Police Department and Tony Zoppi, a reporter with the "Dallas Morning News," were friends with the subject as each had come to the club on numerous occasions and gone to the subject's office to discuss matters with him. All information in the possession of these individuals must be obtained.

Reagan Turman, Los Angeles, California, has stated be believed he heard the name of J. D. Tippit mentioned by the subject and he knows the subject is a good friend with one Lt. Arnett, first name believed to be George. Interview Lt. Arnett to establish the extent and degree of his association with subject. Obtain from Lt. Arnett any knowledge of association between subject and Officer Tippit.

Mrs. Paul Calgrove, Houston, an exotic dancer, advised the husband of a former landlady in Dallas was LeRoy Hulse, a uniformed patrolman of the Dallas Police Department. Patrolman Hulse allegedly told her several times of having bounced numerous people from the Vegas Club and the possibility exists Hulse has been employed on a part-time basis at this club. Contact Hulse in order to resolve this fact and obtain all information in his possession.

Truitt Walton, Dallas Police Department, according to Mrs. Paul Salos used to appear at the Carousel Club during off-duty hours and appeared to know the subject quite well. Walton should be thoroughly interviewed.

Don Tabon alleged that in early February, 1963, he was attacked by the subject at the Adolphus Hotel, filed a complaint against the subject and received a telephone call at his home from a detective, whose first name was believed to be Tommy, suggesting that he drop the complaint against the subject. Attempt to identify this detective obtaining the circumstances surrounding this matter and his association with the subject.

Rerep contains a listing of individuals possessing permanent pass cards to the Carousel Club. Ascertain whether or not any of these individuals are law enforcement officers and in the event it is ascertained that they are law enforcement officers, interview them relative to association with subject.

Contact W. E. Naylor, Department of Public Safety, Chief, Narcotics Division, Austin, Texas, for any information in his possession concerning subjects it being noted subject possessed a business card of Naylor's. Airtel to SAC, Tas RE: JACK L. RULL, AKA.

All phases of this investigation must be completely and thoroughly explored. Bear in mind the heretofore-mentioned items are not all inclusive.
