REVIEW OF FILM SHOT BY WBAP- TV DALLAS AT NBC NEW YORK.

SA WILLIAM G. BARRY REVIEWED ALL VIDEOTAPE IN THE POSSESSION OF NBC ON DECEMBER THREE, NINETEEN SIXTY THREE, CONCERNING THE EVENTS IN DALLAS THE WEEKEND OF NOVEMBER TWENTY TWO- TWENTY FOUR, NINETEEN SIXTY THREE, AND RUBY DOES NOT APPEAR IN ANY OF THIS TAPE.

SA THOMAS PETTIT, NBC NEWS CORRESPONDENT ON DECEMBER THREE, NINETEEN SIXTY THREE ADVISED SA WILLIAM G. BARRY THAT FOR THREE DAYS HE HAD REVIEWED ALL FILM IN THE POSSESSION OF NBC AND HAD BEEN UNABLE TO LOCATE ANY FILM IN WHICH RUBY APPEARED. HE SAID IF HE DOES LOCATE ANY FILM OF RUBY, HE WILL ADVISE NYO IMMEDIATELY.

PETTIT POINTED OUT THAT VIDEOTAPE CAN BE ERASED BUT FILM CANNOT THEREFORE, IT WOULD APPEAR THAT JETT/SONNEN, DIRECTOR, FILM SERVICES, WBAP- TV DALLAS, TEXAS, MENTIONED IN RE TEL MUST HAVE BEEN REFERRING TO VIDEOTAPE AND NOT FILM.
