FOLLOWING ARE ACTIVITIES OF JACK L. RUBY ON NOV. TWENTY-TWO LAST. UNABLE TO OBTAIN EXACT CHRONOLOGY.

JACK L. RUEY STATES AFTER ASSASSINATION OF PRESIDENT HE PLACED CLOSED SIGNS ON HIS NIGHT CLUBS. WENT TO TEMPLE SHEARITH ISRAEL FOR WORSHIP. THAT EVENING WENT TO DELICATESSEN AND HAD SANDWICHES MADE FOR POLICE WORKING ASSASSINATION AND RELATED MATTERS. POLICE HAD EATEN SO TOOK SANDWICHES TO PERSONNEL OF RADIO STATION KLIF. WENT TO POLICE BLDG. AND THERE SAW LEE HARVEY OSWALD, WHO WAS UNDER POLICE ESCORT BEING SHOWN TO NEWSMEN. RETURNED HOME, READ NEWSPAPERS AND WATCHED TELEVISION. 444 Julie -543 GEORGETSENATOR, ROOMMATE OF JACK L. RUBY, STATES IN MORNING

ANDREW ARISTRONG, JR., BARTENDER FOR RUBY AT CLUB CAROUSEL, -STATES HE RECEIVED CALL FROM RUBY FROM OFFICE OF DALLAS MORNING NEWS. RUBY TOLD HIM TO BE CLOSED FOLLOWING THREE DAYS DUE TO END PAGE ONE 53 DEC 11 1953 PAGE TWO

DEATH OF PRESIDENT KENNEDY.

EVA L. GRANT, SISTER OF RUEY, DALLAS, STATES SHE RECEIVED ABOUT EIGHT PHONE CALLS AND THREE VISITS FROM RUBY THAT DAY. THEY DISCUSSED ASSASSINATION OF PRESIDENT, RUEY CALLED NEWSPAPERS REGARDING ADVERTISING CHANGES FOR HIS CLUBS RESULTING FROM ASSASSINATION. ONE VISIT FROM RUBY LASTED FROM ABOUT FIVE THIRTY P. M. UNTIL ABOUT SEVEN FIFTEEN P. M. WHEN RUBY LEFT FOR SYNAGOGUE.

ROSE /MRS. JOHN W. / BACKSON, WAITRESS, BULL PEN DRIVE IN RESTAURANT, ARLINGTON, TEX., STATES RUEY CALLED THERE FOR RALPH PAUL, THE OWNER, TIME UNKNOWN. SHE TOLD HIM PAUL WAS HOME. SHE HAD NO FURTHER CONVERSATION WITH RUEY.

ROBERT T./BROWN, BUSINESS PROPERTY OWNER IN DALLAS, STATES HE RECEIVED PHONE CALL FROM RUBY THAT DAY. RUBY HAD CALLED PREVIOUS DAY WHEN BROWN WAS OUT OF TOWN. RUBY WAS INTERESTED IN BUILDING BROWN OWNS AND WANTED TO SEE IT. LATER THAT DAY, BROWN SHOWED RUBY AND RUBY-S DECORATOR, THE BLDG. UNKNOWN WHAT TIMES OF DAY THESE EVENTS OCCURRED BUT LOGICAL TO BELIEVE THEY WERE BEFORE ASSASSINATION OF PRESIDENT KENNEDY.

EILEEN /MRS. HAROLD RAMINSKY, RUBY-S SISTER, CHICAGO, ILLINOIS, STATES RUBY CALLED HER FROM DALLAS BETWEEN ONE AND THREE P. M. TALKED FOR FIVE MINUTES. SHE TOLD HIM TO BE AS SISTER EVA-S HOME, END PAGE TWO

DALLAS, AT NINE P. M. AND SHE WOULD CALL. WHE CALLED AND WAS TOLD RUBY HAD LEFT FOR SYNAGOGUE.

HYMANTRUBENSTEIN, RUBY-S BROTHER, CHICAGO, ILLINOIS, STATES RUEY CALLED HIM THAT NIGHT. NO INFO. RE TIME OR DURATION OF CALL. HENRY WADE, DALLAS CO. DISTRICT ATTORNEY, STATES HE SAW RUEY STANDING AMONG LARGE GROUP OF CAMERAMEN AND REPORTERS AT POLICE BLDG. THAT NIGHT WHEN LEE HARVEY OSWALD WAS BEING SHOWN TO NEWSMEN.

A. D. HODGE, BAR AND TRADING POST OWNER AND FRIEND OF RUBY, STATED HE SAW RUBY IN ELEVATOR ON SECOND OR THIRT FLOOR OF POLICE BLDG. THAT NIGHT. RUBY GREETED HIM. DOES NOT KNOW RUBY-S PURPOSE IN BEING THERE BUT ASSUMES IT WAS SAME AS HIS, TO HELP POLICE.

HILLEL/SILVERMAN, RABBI, TEMPLE SHEARITH ISRAEL, STATED RUBY AT THAT SYNAGOGUE FROM ABOUT EIGHT THIRTY P. M. TO TEN P. M. THAT NIGHT.

LT. JAMES R. GILMORE, DALLAS PD, STATES HE SAW RUBY IN ASSEMBLY ROOM AT DALLAS PD, WHERE PRESS CONFERENCE IN PROGRESS NEAR MIDNIGHT. SAW RUBY AGAIN FEW MINUTES LATER IN PASSAGEWAY IN POLICE BLDG. END PAGE THREE

AND RUBY TOLD HIM HE HAD DISTRIBUTED SOME SANDWICHES TO PERSONNEL OF RADIO STATION KLIF. SAW RUBY AGAIN FEW MINUTES LATER IN BASEMENT OF POLICE BLDG. BUT PAID HIM NO ATTENTION.

ALEXANDER P. CRUBER, FRIEND OF RUBY, LOS ANGELES, CAL., STATED HE IS LIFÉLONG FRIEND OF RUBY. VISITED WITH RUBY IN DALLAS WHILE PASSING THROUGH DALLAS IN RECENT PAST. STATES THAT ABOUT TWENTY MINUTES AFTER PRESIDENT KENNEDY ASSASSINATED, HE RECEIVED TEL. CALL FROM RUBY. RUBY WANTED TO KNOW IF HE HAD HEARD WHAT HAPPENED. THEY DISCUSSED THE EVENT OF THAT DAY AND HE GOT IMPRESSION RUBY VERY UPSET, AND CRYING AND AGITATED.

CHARLES STATLER, WHO REFUSED TO GIVE HIS ADDRESS OF PHONE NUMBER, STATES HE SAW RUBY AT MAYFLOWER CAFE, DOWNTOWN, DALLAS,

FOLLOWING ARE ACTIVITIES OF RUBY ON NOV. TWENTY-THREE, LAST. UNABLE TO OBTAIN EXACT CHRONOLOGY.

EVA L. GRANT STATES RUBY VISITED HER IN MORNING. TOLD HER HE HAD BUMMED AROUND WITH ONE ARRY, AND EMPLOYEE OF CLUB CAROUSEL, ALL PREVIOUS NIGHT AND WENT TO BILLBOARD ON CENTRAL EXPRESSWAY WHICH HAD SIGN ADVOCATING IMPEACHMENT OF EARL WARREN. THIS SIGN HAS BOTHERED RUBY AND HE CLAIMED TO HAVE HAD LARRY PHOTOGRAPH IT. END PAGE FOUR

## PAGE FIVE .

SHE SAID WHILE RUBY AT HER HOME, HE PHONED ATTORNEY STANLEY KAUFMAN, DALLAS, AND COMPLAINED TO HIM ABOUT ARTICLE IN LOCAL NEWSPAPER WRITTEN BY ONE BERNARD BERNSTEIN CRITICIZING PRESIDENT KENNEDY. RUBY THEN LEFT AND RETURNED TO HER HOME ABOUT FOUR P. M. AND REMAINED UNTIL ABOUT EIGHT P. M. RUBY PHONED HER ABOUT TEN TWENTY P. M., SAID HE WAS GOING TO RADIO STATION KLIF. STATES SHE BELIEVES HE HAD BEEN AT HIS APT. FROM TIME HE PREVIOUSLY LEFT HER HOME UNTIL HE REAPPEARED AT FOUR P. M. STATES RUBY PHONED HER AGAIN ABOUT ELEVEN THIRTY P. M. SAID HE HAD BEEN TO <u>RADIO</u> STATION KLIF, TALKED TO DISTRICT ATTORNEY HENRY WADE AND <u>RUSS</u> KHIGHT, OF KLIF.

JACK RUBY STATES HE DROVE TO PLACE WHERE PRESIDENT KENNEDY ASSASSINATED THAT MORNING. SPENT ABOUT ONE HOUR THERE AND TALKED TO OFFICER CHANEY, DALLAS PD, WHO WAS ON DUTY THERE. HE THEN RETURNED HOME, READ NEWSPAPERS AND WATCHED TELEVISION. THAT NIGHT HE CALLED TOP OFFICER, AND TALKED.

GEORGE SENATOR STATES HE WAS AWAKENED ABOUT THREE OR FOUR A. M. BY RUBY COMING HOME. RUBY SAID HAD BEEN TO SISTER-S HOME. AT FOUR THIRTY OR FIVE A. M., HE AND RUBY WENT TO COFFEE SHOP OF END PACE FIVE PAGE SIX

SOUTHLAND HOTEL, WHERE SPENT TEN OR FIFTEEN MINUTES. THEY THEN RETURNED TO APARTMENT AND WENT TO BED. RUBY WAS STILL AT APART-MENT WHEN SENATOR LEFT BETWEEN ELEVEN A. M. AND ONE P. M. WHEN SENATO.. RETURNED HOME IN EVENING, RUBY WAS THERE. SHORTLY THEREAFTER, RUBY LEFT APARTMENT TO SEE HOW THINGS WERE AT THE CLUE, WHICH WAS CLOSED. HE DOES, NOT KNOW WHEN RUBY RETURNED HOME, AS HE WAS ASLEEP.

STANLEY F. KAUFMAN, ATTORNEY, STATES RUBY PHONED HIM DURING MORNING. RUBY COMPLAINED TO HIM ABOUT NEWSPAPER ARTICLE WRITTEN BY ONE BERNARD BERSTEIN IN LOCAL NEWSPAPER CRITICIZING PRESIDENT KENNEDY. RUBY TOLD HIM HE HAD BEEN TO DALLAS NEWS ADVERTISING DEPT. AND QUOTE RAISED HELL, END QUOTE.

HILLEL SILVERMAN, RAEBI, STATES RULY AT TEMPLE SHEARITH ISRAEL FROM NINE A. M. UNTIL NOON.

ANDREW ARMSTRONG, JR., BARTENDER, CLUB CAROUSEL, STATES LAST CONTACT WITH RUEY ABOUT NINE P. M. STATES RUEY APPEARED TO SOUND MUCH CALMER THAN DURING CONTACT PREVIOUS DAY WHEN HE CALLED RE CLOSING OF CLUBS.

FOLLOWING ARE ACTIVITIES OF RUBY ON NOVEHBER TWENTY-FOUR, LAST. UNABLE TO OBTAIN EXACT CHRONOLOGY. END PAGE SIX CAROUSEL SLUB WAS IN APARTMENT. ABOUT TEN THIRTY A. M. RUBY LEFT, SAYING HE WAS TAKING DOG BACK TO CLUB. THIS WAS LAST CONTACT SENATOR HAD WITH RUBY.

PAGE EIGHT

ELNORA PLTTS, DALLAS, WHO CLEANS RUBY-S APARTMENT, STATES SHE CLEANS ONCE PER WEEK, USUALLY ON SUNDAY. STATES SHE CALLED RUBY AT HIS APARTMENT ABOUT EIGHT A. M. SHE TOLD RUBY SHE HAD SOME WASHING TO DO AND COULD NOT COME THAT MORNING. RUBY ASKED IF SHE COULD COME THAT AFTERNOON ABOUT TWO P. . SHE SAID SHE WOULD BE THERE AT TWO P. M. OR SHORTLY THEREAFTER. RUBY SAID O. K. HE WOULD BE EACK BY THEN. HE SAID HE HAD TO GO OUT BUT WOULD BE EACK BY THEN.

DETECTIVE T. D. MC MILLAN, DALLAS PD, STATED THAT SHORTLY AFTER THE ARREST OF RUEY HE ASKED HIM HOW HE GOT INTO THE BASE-MENT OF THE DALLAS POLICE ELDG. HE STATES RUBY TOLD HIM HE WALKED DOWN THE RAMP FROM MAIN ST. ON THE EAST SIDE. RUBY TOLD HIM HE HAD BEEN TO THE WESTERN UNION OFFICE AND HAD SENT MONEY TO A GIRL IN FORT WORTH AND THEN WALKED TO THE POLICE BLDG. HE ASKED RUBY IN HE WERE CHALLENGED. RUBY TOLD HIM THAT ONE POLICE-MAN, WHOM HE DID NOT NAME, HOLLERED AT HIM BUT HE JUST DUCKED HIS HEAD AND KEPT ON GOING. RUBY TOLD HIM THAT JUST AS HE ARRIVED END PAGE EIGHT

## PAGE NINE

AT THE BOTTOM OF THE RAMP, OSWALD APPEARED. HE ASKED RUBY HOW HE KNEW OSWALD AND RUEY SAID THAT HE WAS PRESENT ON NIGHT OF NOV. TWENTY-TWO AT A PRESS CONFERENCE /IN POLICE BLDG./ AT WHICH TIME OSWALD ALSO PRESENT.

INVESTIGATION CONTINUING TO DEVELOP ANY OTHER ACTIVITIES OF RUBY DURING PERTINENT PERIOD.
