BUREAU INTERVIEWED THIS DATE AND STATED THAT
ON OR ABOUT JUNE SEVENTEEN LAST HE WAS HIRED BY A NIGHTCLUB
IN DOWNTOWN DALLAS PAREN NAME OF CLUB AND STREET UN-
RECALLED END PAREN, OWNED OR MANAGED BY A MR. RUBINSTEIN,
AKA QUOTE RUBY END QUOTE, AS A DISHWASHER. BIBEAU WORKED
FOR RUBINSTEIN ABOUT TWO WEEKS. ON ABOUT JUNE NINETEEN
OR TWENTY LAST, WHILE CLEANING TABLES IN CLUB, BIBEAU
HEARD RUBINSTEIN STATE TO A GROUP AT A PRIVATE PARTY AT
CLUB THAT QUOTE NIGGERS SHOULD BE HANGED, NOT PAMPERED
END QUOTE. THIS STATEMENT WAS MADE IN REFERENCE TO
