INTERROGATE THESE PERSONS COLON REMIGIO AGUILAR, EDUARDO

TUBACH, LLOY HORAL. THESE LAST ONES ARE FROM BRAWLEY, CALIFORNIA. NORMA GUTIERREZ, MARIA LUISA SILVA, IRMA

GUTIERREZ. THESE I THINK ARE IMMIGRATED. AT THE HOUSE OF

MR. REMIGIO THEY HELD THEIR MEETINGS AND THEY ARE SURE THAT

THIS JACK WHO KILLED THE ASSASSIN OF YOUR PRESIDENT FOR FEAR

THAT HE WOULD TALK. THIS JACK WAS AT THE MEETINGS THAT ALL

THE ABOVE MENTIONED HELD. WE HOPE YOU WILL INTERROGATE THEM. IT WILL BE VERY EASY BECAUSE THE GIRLS ARE THREATENED WITH DEATH. ALL THE MEXICAN NAMES LIVE IN MEXICALI, B. C., MEXICO. REMIGIO AGUILAR IS VERY WELL KNOWN AND HE CAN INFORM YOU WHERE THE REST LIVE. WE HOPE THIS WILL SERVE YOU OF SOME INFORMATION. UNQUOTE.

EDUARDO TUBACH, BRAWLEY, CALIFORNIA, WHO IS MENTIONED IN ABOVE LETTER, WAS LOCATED ON DECEMBER THREE LAST REGARDING ANONYMOUS LETTER. TUBACH IS OF THE OPINION THE LETTER IS A QUOTE SPITE UNQUOTE LETTER. INVESTIGATION HAS DETERMINED THAT REMIGIO AGUILAR IS THE OWNER OF THE MAJOR CATTLE SHIPPING YARDS IN MEXICALI, B. C., MEXICO, AND LLOYD E. HORAL IS ONE OF THE FOREMEN WORKING FOR TUBACH WHO HAS EXTENSIVE RANCHING ENTERPRISES IN IMPERIAL COUNTY, CALIFORNIA. TUBACH HAS FURNISHED INFORMATION THAT NORMA GUTIERREZ WAS A QUOTE GIRLFRIEND UNQUOTE OF AGUILAR, THAT IRMA CUTIERREZ WAS THE QUOTE GIRLFRIEND UNQUOTE OF HORAL, AND THAT MARIA LUISA GARCIA SILVA WAS HIS QUOTE GIRLFRIEND UNQUOTE.

APPROXIMATELY FOUR YEARS ACO, TUBACH COMMENCED VISITS TO MEXICALI WHERE HE RENTED AN APARTMENT NEAR THE CORNER OF

AVENUE COMPUERTAS AND CALZADO JUSTO SIERRA. HE HAD MET  
MARIA LUISA GARCIA SILVA AND THEY RESIDED IN THE APARTMENT  
AS MAN AND WIFE. NORMA CUTIERREZ RESIDED IN THE NEXT  
APARTMENT, AND ABOUT A YEAR AGO HE BECAME ACQUAINTED WITH  
AGUILAR WHO VISITED HER WITH REGULARITY. AT ABOUT THAT TIME,  
HORAL, THROUGH NORMA GUTIERREZ AND MARIA LUISA GARCIA SILVA,  
BECAME ACQUAINTED WITH IRMA GUTIERREZ. HE DROPPED  
SILVIA GARCIA VIRGENES AND COMMENCED A RELATIONSHIP WITH IRMA  
GUTIERREZ. MEXICO

THIS ANGERED SILVIA GARCIA VIRGENES WHO THREATENED TO  
HAVE BOTH TUBACH AND HORAL ARRESTED AND EXPELLED FROM MEXICO.  
BOTH HAD BEEN VISITING MEXICALI WITHOUT PROPER DOCUMENTS.  
SHE ALSO THREATENED TO CAUSE THEM OTHER UNSTATED EMBARRASMENTS.

INVESTIGATION CONTINUING IN IMPERIAL COUNTY TO DEVELOP  
ALL FACTS CONCERNING QUOTE JACK UNQUOTE MENTIONED IN THE  
ANONYMOUS LETTER. REPORT FOLLOWS.
