QUESTION NO EIGHT, ~~RUSSELL LEE MOORE~~, AKA, ~~RUSS KNIGHT~~,
A DISC JOCKEY AT KLIF RADIO STATION, DALLAS HAS ADVISED BUREAU
AGENTS THAT HE WAS ON DUTY AT THE RADIO STATION DURING THE
LATE EVENING, NOV. TWENTYTWO LAST, AND EARLY MORNING,
NOV. TWENTYTHREE LAST, AND ~~GLEN DUNCAN~~, AN EMPLOYEE KLIF, TOLD
HIM JACK RUBY HAD CALLED TO SEE IF HE WAS INTERESTED IN AN
INTERVIEW WITH DALLAS DA, HENRY WADE. RUBY HAD INDICATED
HE WAS CALLING FROM THE PD. MOORE SENT TO THE PD
BUT LEARNED WADE HAD ALREADY MADE A STATEMENT TO THE
PRESS. HE WAS, HOWEVER, DIRECTED TO WADE BY RUBY
AND MOORE TALKED TO WADE. MOORE RETURNED TO THE RADIO STATION
AT APPROXIMATELY ON FORTYFIVE AM, REC-114

NOVEMBER TWENTYTHREE LAST AND RUBY WAS THERE. RUBY HAD BROUGHT SANDWICHES AND SOFT DRINKS TO THE STATION. MOORE DOES NOT RECALL SPECIFICALLY ANY STATEMENTS OF RUBY BUT RECALLS HE WAS GRIEVING FOR THE KENNEDY FAMILY.

GLEN DUNCAN, NEWS ANNOUNCER, KLIF, DALLAS, ADVISED BUAGENTS HE WAS ON DUTY NIGHT OF NOV. TWENTYTWO AND EARLY MORNING, NOV. TWENTYTHREE LAST, AND RECALLS RECEIVING TWO TELEPHONE CALLS FROM JACK RUBY SOMETIME DURING THE EARLY MORNING OF NOV. TWENTYTHREE LAST. ONE OF THESE TELEPHONE CALLS WAS AS TO WHETHER KLIF WANTED TO INTERVIEW HENRY WADE CONCERNING THE OSWALD CASE INDICATING HE WOULD ENDEAVOR TO LOCATE WADE AND PUT HIM IN TOUCH WITH DUNCAN. RUBY INDICATED TO DUNCAN THAT HE WAS AT THE POLICE STATION AND APPARENTLY WADE WAS THERE ALSO. HE STATED THAT IN THE SECOND TELEPHONE CALL RUBY PUT WADE ON THE TELEPHONE AND DUNCAN TAPED AN INTERVIEW WITH WADE. SHORTLY AFTER THESE CALLS, RUBY CAME TO THE KLIF RADIO STATION WITH SANDWICHES AND SOFT DRINKS. DUNCAN DESCRIBED

QUESTION SEVEN/ DUNCAN STATES IT IS HIS UNDERSTANDING THAT WHEN RUBY
FIRST CALLED ON EARLY MORNING NOVEMBER TWENTYTHIRD, HE HAD
OBTAINED KLIF TELEPHONE NUMBER WHICH IS SEMI PRIVATE LINE
FROM ~~DANNY MC CUDY~~, AKA., ~~DANNY PATRICK~~ WHO WAS ON DUTY AT
THE RADIO STATION AT THE PHONE NUMBER LISTED IN THE DALLAS
TELEPHONE DIRECTORY FOR KLIF.
