QUESTION NO. EIGHTEEN, JAMES E. DUNNE, II, LOUISVILLE,  
KENTUCKY, STATES IN LATE FALL, NINETEEN FIFTYNINE, HE LOANED  
JOE SLAYTON, DALLAS, ABOUT FIVE THOUSAND DOLLARS WHICH SLAYTON  
USED TO ESTABLISH THE SOVEREIGN CLUB, DALLAS, WHICH CLUB OPENED  
IN JANUARY OR FEB., NINETEEN SIXTY, WITH JACK RUBY AS PARTNER  
OF SLAYTON. DUNNE OF THE OPINION RUBY INVESTED TEN THOUSAND DOLLARS.  
THIS CLUB WAS NOT A SUCCESS AND SLAYTON, WITH DUNN/S PERMISSION,  
GOT OUT OF THE CLUB LEAVING RUBY ENTIRE OPERATION. DUNNE RECEIVED  
NOTING FROM LOAN TO SLAYTON. RUBY CHANGED NAME TO CAROUSEL CLUB  
AND CONTINUED AS A PUBLIC CLUB, INCLUDING STRIP TEASE, RATHER  
THAN A PRIVATE CLUB.

RALPH PAUL, ARLINGTON, TEXAS, ON NOV. TWENTYFOUR, STATED HE  
LOANED MONEY TO S AND R, INC., WHICH WAS FORMER BY JOE SLAYTON,

AND JACK RUBY ENGAGED THEIR OPERATION OF THE SOVEREIGN CLUB AND INVESTED MONEY ALSO RESULTING IN JACK RUBY GIVING HIM FIFTY PER CENT OF THE STOCK OF THIS CORPORATION, AND IN THE CAROUSEL CLUB, OWNER BY THE CORPORATION. ON NOV. TWENTYEIGHT LAST, PAUL CLAIMED HE RECEIVED FIVE HUNDRED SHARES OF STOCK FROM RUBY AFTER SLAYTON HAD WITHDRAWN OUT OF THE CORPORATION, AS COLLATERAL FOR LOANS, RATHER THAN AS INDICATED AND DOES NOT CONSIDER HE OWNS ANY OF THE CAROUSEL CLUB. CLAIMS BELIEVES JACK RUBY OWNS FIVE HUNDRED SHARES, PLEDGED TO PAUL AND EARL RUBY, BROTHER, OWNS THE REMAINING FIVE HUNDRED SHARES.

CAPT. W. P. GANNAWAY, SPECIAL SERVICES BUREAU, DALLAS PD., ADVISED APPLICATION FOR BEER LICENSE FOR CAROUSEL LISTS OWNER AS S AND R, INC., RALPH PAUL, PRESIDENT, JACK RUBY, VICE-PRESIDENT, AND SAMUEL D. RUBY AS SECRETARY-TREASURER.

EARL R. RUBY, SOUTHFIELD, MICH., INTERVIEWED IN CHICAGO, NOV. TWENTYEIGHT LAST, ADVISED HE HAS NO INFO CONCERNING THE CORPORATION S AND R. STATES HE LOANED MONEY TO BROTHER JACK WHEN HE WAS

ENTERING BUSINESS AS THE SOVEREIGN CLUB. THIS MONEY WAS REPAYED AND EARL OWNS NO PART OF THE SOVEREIGN CLUB OR ITS SUCCESSOR, THE CAROUSEL.

EVA GRANT, RUBY/S SISTER, REINTERVIEWED NOV. TWENTYEIGHT LAST, AND ADVISED SHE AND JACK RUBY EACH OWN FIFTY PER CENT OF VEGAS CLUB. STATES CAROUSEL OWNED S AND RA CORP., AND RALPH PAUL AND JACK RUBY EACH OWN FIFTY PER CENT OF CAROUSEL. JACK RUBY HAS BANK ACCOUNT IN NAME S AND R, INC., DBA CAROUSEL.

TAX FORM TO TEXAS EMPLOYMENT COMMISSION ON OCT. TWENTYFIVE, SIXTYONE, IS SWORN TO BY JACK RUBY, STATES S AND R, INC., PURCHASED THE SOVEREIGN CLUB AND CHANGED NAME TO CAROUSEL ON APRIL ONE, SIXTYONE. OFFICERS LISTED ARE RALPH PAUL, PRES., ARLINGTON, TEX., SAM RUBY, VICE-PRESIDENT, DALLAS, JACK RUBY, VICE-PRESIDENT AND GENERAL MANAGER AND BUDDY TURMAN, SECRETARY-TREASURER, TYLER, TEXAS.

REAGAN QUOTE BUDDY UNQUOTE TURMAN, INTERVIEWED IN LOS ANGELES AND CLAIMED HE WORKED FOR JACK RUBY FOR THE LAST FIVE YEARS ON DIFFERENT OCCASIONS AND LAST WORKED FOR HIM JAN. NINETEEN, SIXTYTHREE. NOT QUESTIONED AS TO OWNERSHIP OF S AND R OR CAROUSEL.

DUNN AND BRADSTREET, DALLAS, HAS NO FILE ON S AND R OR CAROUSEL BUT DOES HAVE FILE ON SOVEREIGN CLUB WHICH IS LISTED AS BEING OWNER BY SLAYTON AND AN OLD FILE ON JACK RUBY WHICH IS BEING OBTAINED.

ON NOV. TWENTYNINE INSTANT, SAMUEL D. RUBY ADVISED HE HAS NEVER HAD ANY INTEREST IN ANY CLUBS AND DID NOT KNOW HE WAS LISTED AS AN OFFICER OF S AND R, INC.
