 INTERVIEW WITH NEWSMEN.

MAURICE CARROLL, NEW YORK HERALD TRIBUNE REPORTER LOCATED
 AT NYC DECEMBER SIX. HE WAS IN DALLAS MUNICIPAL BUILDING BEFORE TEN AM
 NOVEMBER TWENTY FOUR LAST. HE WAS ON THE THIRD FLOOR OF THE BUILDING
 AND OBSERVED OSWALD TAKEN FROM A ROOM ON THE THIRD FLOOR TO AN ELEVATOR
 ON THE SAME FLOOR. HE THEN RAN DOWNSTAIRS TO THE BASEMENT. HIS
 CREDENTIALS WERE CHECKED WHEN HE ENTERED THE THIRD FLOOR AND ALSO BEFORE
 HE ENTERED THE BASEMENT.

HE DOES NOT KNOW OF ANY UNAUTHORIZED PERSONS PERMITTED TO ENTER
 WITHOUT SHOWING IDENTIFICATION. HE HAS NO INFORMATION CONCERNING
 ANY POLICE OFFICER OR OTHER OFFICIAL CONSPIRING WITH RUBY TO KILL
 OSWALD.

HE DID NOT SEE RUBY AT ANY TIME FROM NOVEMBER TWENTY TWO TO
 NOVEMBER TWENTY FOUR.
