WALLY WESTON was interviewed at the Theatre Lounge, 1326 Jackson Street, Dallas, Texas. He advised at the present time he is filling an entertainment contract at the Kings Club in Oklahoma City, Oklahoma and he is visiting in Dallas only temporarily. He maintains an apartment in Dallas at 4617 Samuels Boulevard, Apartment 131. WESTON stated he and his wife SHARI ANGEL WESTON, who is an exotic dancer known as SHARIE ANGEL, are both acquainted with JACK RUBY, owner of the Carousel Club on Commerce Street in Dallas. WESTON continued he has known RUBY intimately for three or four years and worked for RUBY at the Carousel Club for fourteen months as master of ceremonies. He said he presumed that his continued friendship with RUBY has come about as a result of his respect for RUBY'S eccentricities and temper. He said over his period of acquaintance with RUBY, he has known when to discontinue an argument with RUBY before RUBY had an opportunity to become violent. He has known RUBY to become so infuriated at a person in an argument, RUBY would strike the person with whom he was arguing. He stated RUBY was a very impulsive person who would make a statement at a time of one of his temper tantrums and later he would have completely forgotten the incident which provoked such a remark. On one occasion he became extremely angry at a drummer in his orchestra and threw him down a flight of stairs and two days later he asked the drummer why he hadn't reported for duty, having completely forgotten that he told the drummer, "you can't quit because I fired you", at the time he threw him down the stairs. WESTON stated this was typical of RUBY'S impulsiveness. WESTON said he has never known RUBY to have any particular interest in politics nor has he been a member of any organizations that WESTON could recall. WESTON said he has never heard RUBY express any Un-American sentiment and he had no reason to believe RUBY is not a loyal American citizen in every respect. He advised RUBY has always had a strong desire to be somebody and he is a "publicity hound". WESTON pointed out when the United States was swept by the 50-mile hike craze, he and RUBY conceived a plan for WESTON to make a 50-mile hike for publicity purposes for the Carousel Club. RUBY was to contact the news media in Dallas and create as much publicity on WESTON'S hike as possible; however, RUBY failed on the publicity part and the hike did not receive the publicity they both anticipated.

WESTON said RUBY is continuously seeking to promote business for himself at the Carousel Club and because of this he is friendly and tried to be friendly with persons he thinks will be good for his business. RUBY has spent much time around the Police Department in Dallas, the Sheriff's Office and other public places handing out business cards entitling the person receiving same to admittance to the Carousel Club and free drinks as a guest. WESTON said he knew RUBY had many friends at the Dallas Police Department as a result of promotional activities. He stated it was his personal opinion and belief that RUBY possibly murdered LEE HARVEY OSWALD for two reasons. He felt one reason could have been RUBY'S strong desire for national publicity which would result from his act or RUBY, because of his violent temper, could have become angered at the murderer of a member of the Dallas Police Department, whom he felt were his friends. WESTON said he did not believe OSWALD'S murder was connected in any way with RUBY'S political beliefs or because of RUBY'S sympathy for some foreign Government. He added he has never heard RUBY criticize the American form of Government, the leaders of this country, nor has he ever expressed any radical ideas. WESTON recalled RUBY was extremely sensitive about his being of Jewish extraction and for that reason WESTON had received specific instructions from RUBY that in his job as master of ceremonies he was to stay completely away from any jokes or comments of a racial or political nature.

WESTON said he knew RUBY did have a gun in his possession based on the following instances. About eight months ago there was an attempted burglary at the Carousel Club, which was discovered by RUBY upon his entrance into the club. RUBY ran down the back stairs of the club to his automobile, which was parked on a nearby street, secured a gun from the automobile and returned to the club, thinking the burglars still might be in the club. About six months ago two customers arriving at the club were approached by one of the club employees to pay their \$2.00 fee for entrance into the club. These customers reported they had paid \$2.00 to two young men who were standing at the downstairs entrance to the club as they entered. RUBY ran down the stairs just in time to see the two young boys running up the street. RUBY ran to his automobile which was nearby, got his pistol out of the trunk of the car, put it in his shirt, and began looking around for the boys. Shortly thereafter the two boys were apprehended by officers of the Dallas Police Department, at which time they were returned to the Carousel Club. When the officers took the boys to RUBY to inquire whether he wanted to file charges against the boys, RUBY hesitated and then instructed the officers to forget the whole matter because there was so little money involved.

RUBY instructed the police to admonish the boys for their actions and then to release them.

WESTON concluded by advising because of RUBY'S peculiar personality and violent temper, RUBY has no close personal friends. WESTON stated he felt he was possibly closer to RUBY than anyone else he knew, because over the period of three or four years, he has learned how to get along with RUBY. He added with regard to the incident when entertainer BILL DE MAR who is presently appearing at the Carousel Club reported he had seen LEE HARVEY OSWALD at the club, WESTON did not feel DE MAR could have recognized OSWALD because of the difficulty experienced in recognizing persons in the audience from the stage. WESTON pointed out a performer has a spotlight shining in his face while he is on stage and it would be very difficult for the performer to recognize anyone looking into the audience from the stage. He felt DE MAR had made the claim he saw OSWALD in the audience because of DE MAR'S desire for publicity.

Mr. WESTON said he has not seen RUBY since the President's assassination on November 22, 1963 and he is unable to account for his whereabouts since that time.

Miss DOROTHY MARCUM, 112½ S. Ward, advised she has been employed as a bookkeeper and office girl for the J. B. COWAN MOTOR CO, Waxahachie, Texas, during the past several years. She advised she has an aunt named BILLIE HADLEY, who lives at 3523 Mt. Pleasant Street, Dallas, Texas, and is employed as a waitress at the Carousel Club, which is owned and operated by JACK RUBY. She advised she has visited her aunt at Dallas on three occasions during the past several years and on each occasion was in the Carousel Club and knows JACK RUBY very casually. She stated she has never dated JACK RUBY, knows nothing of his character, background or associates and definitely could furnish no information as to RUBY's possible association with LEE HARVEY OSWALD. She advised that her aunt is a married woman with four children and works at RUBY's club on a part-time basis. She said she contacts her aunt by telephone once or twice a week and since the assassination of President KENNEDY, she has talked with her aunt several times. She advised her aunt never made any mention of knowing LEE HARVEY OSWALD or of OSWALD's association with RUBY.

WAHRMUND, 4637 San Jacinto Street, Apartment 1, was visiting in his home and informed him that his son, KARL WAHRMUND, is a musician and piano tuner.

While watching television, WAHRMUND remarked, "KARL lost two accounts over RUBY shooting LEE HARVEY OSWALD." He explained KARL serviced the pianos in the two night clubs owned by RUBY and, since RUBY had been arrested for the murder of OSWALD, assumed that the two night clubs would close.

WISE continued that WAHRMUND remarked that his son, KARL, was in the Carousel Club, 1312 1/2 Commerce Street, approximately two weeks ago and observed LEE HARVEY OSWALD in the club. KARL assumed that OSWALD worked there, but did not speak to OSWALD. He advised that this information came from the elder WAHRMUND and he had no additional information concerning the association between OSWALD and RUBY.

I. T. (TROY) ~~RUCKLEY~~, Emory, Texas, was interviewed, at which time he was advised of the identity of the interviewing agents. ~~RUCKLEY~~ then furnished the following information:

Re: Kley

On Friday night, November 8, 1963, he was on his way back from Wichita Falls, Texas to Emory, Texas when he stopped in Dallas, Texas with intentions of doing some work on Saturday, November 9, 1963 at the Standard Oil Company of Texas offices. He said he stopped at the Baker Hotel where he planned to register then "see some sights". On the way into the Baker Hotel lobby, he said he met a "man from the Texas Company" whose name is something like "FARRAGUS" and that this man told him the company offices would not be open on Saturday. RACKLEY asked him where he could see some of the sights and this man told him to go to the Carousel Club which is northeast of the Baker Hotel and about two blocks away.

RACKLEY said he walked to this club and entered some time between 9:30 p.m. and 10:00 p.m. RACKLEY stated he had had about two drinks before he went to the club and that when he entered his waitress, who was blonde and wearing a "neglige type dress over very little else" served him bourbon and water. At this time RACKLEY said he noticed two men sitting about 15 feet from him at a table and he asked the waitress who these men were. She said the big guy was her "boss" and she referred to him as "JACK". RACKLEY explained that JACK was the same man known to him from television pictures as JACK RUBY, the Manager of the Carousel Club, and the man who shot "the assassin of President KENNEDY". However, RACKLEY stated the waitress called the other man "~~PETTIT~~" or "~~PETTIT~~", he couldn't recall which name she used. He continued by identifying the waitress as the blonde-haired girl who was on television Sunday night, November 24, 1963 from a Dallas television station and the one who said she did not like RUBY and did not get along with him very well. He said that "~~PETTIT~~" or "~~PETTIT~~" was the man who was shot by RUBY Sunday morning in Dallas, Texas.

RACKLEY could not describe the Carousel Club other than there was a bar, many tables, and that when he went in the lights were all bright and later they were dimmed. He stated he had to leave before the show started because the drinks hit him and he recalled having only three bourbon and waters at \$1.00 each. RACKLEY also recalled paying an unrecalled cover charge to get in and that there were pictures of girls displayed outside the Carousel Club.

RACKLEY stated after he left he drove his pickup truck to what he believes was the Hillside Tourist Court on old Highway 67 where he spent the night.

RACKLEY further described the Carousel Club as being "near the new telephone building past the Continental Bus Station". He described "JACK", the waitresses "boss" as being a white male, age 40, 5' 10" or 5' 11", but nothing else noted except he was identical with the television picture of JACK RUBY.

RACKLEY could not describe ^{"BATTIT"} ~~"VEPTIT"~~ or ^{"PATTIT"} ~~"PEPTIT"~~, other than being a white male except that he was identical with the "killer of President KENNEDY."

HARVEY LAWILL WADE, 818 Donaldson Road, Chattanooga, Tennessee, employed as a building inspector in the City of East Ridge, Tennessee, furnished the following information:

WADE attended Southern Building Congress Convention, Dallas, Texas, November 10-14, 1963. He arrived the afternoon of November 10, 1963, and stayed at the Baker Hotel, Dallas. At 11:00 PM, November 10, 1963, WADE visited the Carousel Night Club alone and remained until 1:00 AM. The entertainment consisted of three strippers and emcee BILL DEMERIS (PH). A stripper wearing a platinum wig invited a customer to dance with her on the stage as part of her act at about 12:00 midnight. A Carousel employee, a young white male wearing a white waiter's jacket, took two flash photographs with a Poloroid-type camera. From the angle the photograph was taken, three men seated at the bar connected to the stage on the right side of the night club were between the photographer and the stage and possibly in the photographs. WADE believes one of these three men was LEE HARVEY OSWALD, who was dressed in a coat-length jacket, light colored white dress shirt, open collar, no tie, and dark colored pants.

The person believed OSWALD was accompanied by two unknown men. The number one man is described as a white male, early twenties, 5 feet 8 inches, 140 pounds, long black hair, very fair pale complexion, and slender build. He had no unusual characteristics and wore a dark colored suit. He resembled OSWALD in appearance.

The number two man is described as a white male, 30-32 years old, 200 pounds, 5 feet 10 inches, stocky build, long black hair, dark complexion, oval face, and Mexican or Spanish in appearance. He had numerous bumps on his face and was believed to have a one-inch scar in the eyebrow of his left eye.

The customer on the stage with the stripper was a white male, 5 feet 10 inches, 35 years old, 180 pounds, flat-top dark hair, dress not recalled, and was at the table with one girl and three or four men.

The waitress who waited on WADE and the three men in the group, including person believed to be OSWALD, is described as a white female, 37 or 38, 5 feet 1 inch, 110 pounds, black-grey hair shoulder length, ruddy complexion, and a very small face.

BILL DEMERIS, emcee, made the statement, following photographing, they were for blackmail purposes. JACK RUBY, manager, walked over to the photographer, talked to him, and yelled that the photographs did not turn out. The emcee had a memory skit. The person believed OSWALD and his two companions took part in the skit. The person believed OSWALD and friends were in the club when WADE arrived and still at the table at WADE's departure. WADE was seated within ten feet of the person believed OSWALD and his group. WADE alone did not see anyone during the visit known to him. He believes he could identify photographs of the men accompanying the person believed OSWALD.

The person believed OSWALD and his friends were not observed talking to anyone outside their group while at the club. He estimated 75 to 80 customers were present when he arrived and 25 or less when he departed. WADE had no further information.

LEON E. WORTH, 2018 South Tyler Street, Dallas, Texas, was interviewed concerning his knowledge and/or association with JACK RUBY.

Mr. WORTH stated he presently operates a private club at 2707 McKinney Avenue in Dallas known as the Galaxy Club. He stated this is a private club, and he formerly operated the Top Hat Lounge located in Dallas. He stated he operated the Top Hat Lounge about ten years ago at which time JACK RUBY was operating a lounge known as the Silver Spur.

He stated he has known RUBY for approximately ten years and became acquainted with him inasmuch as he was operating the Top Hat Lounge at the same time RUBY was running the Silver Spur.

He stated at no time has he ever considered himself a personal friend of RUBY's and had never to his recollection gone to dinner with him or had drinks with him either in a coffee shop or a lounge.

Mr. WORTH stated about 1954 he divested himself of the lounge business and went in the pharmaceutical business as a pharmacist.

He stated RUBY came to him at the time he was in the pharmaceutical business with a remedy for treating arthritis. He stated RUBY wanted him to sell this arthritis remedy and would receive \$100.00 a week and commissions for selling this remedy.

WORTH stated he sold this arthritis remedy for RUBY for about three months but after that time several of the checks which RUBY gave him for commission were no account checks, and so he quit doing business with RUBY and quit selling his arthritis remedy.

Mr. WORTH stated after he quit selling the arthritis remedy he had no further contact with RUBY, and up until approximately two months ago had not seen him although he had known he was in the Dallas area. He stated he saw RUBY in Phil's Delicatessen with a bunch of show people whom he believed were entertainers at the club operated by RUBY. Mr. WORTH stated he did not know any of these people and did not know of any close friends of RUBY.

He stated he never considered himself a personal friend

of RUBY and had never arranged for any loans nor had he loaned him any money for the purpose of operating a lounge or other business. He stated RUBY is the kind of person who is always trying to force his friendship on you, and he did not consider RUBY trustworthy or reliable and believed that RUBY would do anything for a "buck".

Mr. WORTH stated he was also of the opinion RUBY preferred "gay company" and further explained this by saying he believed RUBY preferred the company of men rather than of women. He stated he has no personal knowledge of homosexual tendencies of RUBY and that RUBY exhibited feminine tendencies in his actions and talk. He stated he did not believe that RUBY was a fighter or brawler as he had been characterized recently in newspaper clippings. He stated RUBY was a backslapper and he believed RUBY would do anything for publicity or money.

He stated he does not know of his own knowledge that RUBY is a narcotics user or that he drinks to excess.

WORTH stated that "JACK is not for anybody else but JACK RUBY". He stated he does not know anything about RUBY's politics and does not believe that RUBY is particularly patriotic or interested in politics other than in politics to promote himself.

Mr. WORTH stated that his wife and RUBY did not get along at all, and he believed that RUBY was jealous of his wife because of the husband and wife relationship.

Mr. WORTH stated he did not ever know RUBY to carry a gun and did not believe RUBY was an aggressive person.

WORTH stated he did not know any close friends that RUBY might have, and he personally did not care for RUBY in any form.

She stated JACK RUBY has no liking for her as she does not like JACK RUBY. She stated she believes RUBY is jealous of her because she is the wife of LEON WORTH. She stated she did not know of any friends of RUBY and had no other information to furnish concerning this person.

Mr. LEON H. WORTH was reinterviewed at the Galaxy Club, located at 2707 McKinney, concerning his association with JACK RUBY.

Mr. WORTH again stated he did not consider himself a personal friend of RUBY and had never loaned him any money or made arrangements for RUBY to obtain financial assistance for the operation of his Carousel Club.

Mr. WORTH repeated that the only business venture he was ever associated with with RUBY was in the sale of an arthritic preparation, which RUBY was trying to promote a year or two ago. Mr. WORTH stated after selling this preparation for sometime, RUBY's commission checks bounced and he, therefore, ceased selling the preparation which RUBY obtained and gave to him.

Mr. WORTH stated the arthritic preparation could not meet high standards prescribed by pharmaceutical houses and he sold his preparation to chiropractors and other "faith" healers who did not need a license to practice medicine.

Mr. WORTH stated he did not know where RUBY obtained the arthritic preparation but believed he prepared it himself.

Mr. WORTH stated he is acquainted with, and ^{Texas} considers himself a good friend of, LEROY MABRAY. He added MABRAY is a member of the Galaxy Club and on the day that RUBY allegedly shot the assassin of President KENNEDY, MABRAY had called him and made inquiry about RUBY.

Mr. WORTH stated he and MABRAY talked about RUBY and the shooting but WORTH denied he told MABRAY that OSWALD, the assassin, and RUBY were good friends. Mr. WORTH stated he could not recall all of his conversation with MABRAY at that time; however, he stated he could not recall making any statements whatsoever to indicate he was at this time a partner of RUBY or that OSWALD and RUBY were the best of friends.

WARWICK JENKINS, 1219 East Marvin, Waxahachie, Texas, advised he is an attorney at law, with offices located at Waxahachie. He advised the J. B. COWAN Motor Company, which company is located adjacent to his offices, employs a young woman named DOROTHY MARCUM as a bookkeeper. He advised MARCUM drinks coffee with employees of his, JENKINS' office.

JENKINS advised that yesterday being November 26, 1963, MARCUM made the comment that she formerly dated JACK RUBY of Dallas, Texas, and has an aunt, name not given, who is in the employ of JACK RUBY at Dallas, Texas. Mr. JENKINS advised he also heard that Miss MARCUM made the statement to a Mr. HUBERT BRADEN, who has Braden Automotive Supply at Waxahachie, that the information furnished by RUBY concerning his association with LEE HARVEY OLSWALD was a lie, as she knew OLSWALD was in RUBY's employ during June and July, 1963.

Mr. JENKINS advised she also made the statement that her aunt is employed by Mr. RUBY had never been interviewed by the FBI and was deadly afraid of such an interview.

ROBERT KERMIT PATTERSON, commonly known as BOB PATTERSON, appeared at the Dallas Field Division at approximately 1:00 PM on November 26, 1963. PATTERSON advised he resides in Room 511 at the YMCA located at 605 North Ervay Street, Dallas, Texas.

PATTERSON stated that at the present time he is unemployed and is dissolving a partnership which he formerly had with DONALD C. STUART in a business which they operated under the trade name Contract Electronics at 2533 Elm Street, Dallas, Texas. He stated their business was the repair of televisions, radios and other small appliances. He stated that he and STUART employed one CHARLES ARNDT, age 18, who resided at Room 516 of the YMCA, as a helper.

About two weeks ago PATTERSON stated he returned to his place of business at approximately 3:00 PM. On his arrival in addition to STUART and ARNDT he found JACK RUBY and a man believed by PATTERSON to be LEE HARVEY OSWALD. He stated that he could not recall being introduced to the man with JACK RUBY but has a vague recollection that the other man was introduced as being from Chicago.

PATTERSON estimated that RUBY and the man he believes to be OSWALD were at the Electronics Shop for approximately one hour during which time their general conversation was generally about the buying and selling of electronics equipment. PATTERSON recalled that RUBY questioned STUART about installing some speakers in the Carousel Club where amplifiers were already present.

Sometime during the discussion RUBY told STUART and PATTERSON that he would give them passes to his club. RUBY pointed out that he did not give passes to everybody but that he would make them available to these two men. RUBY then handed what he referred to as a guest book to the man who was with him and instructed that individual to put the names of STUART and PATTERSON in this notebook. PATTERSON stated that he personally observed the man with RUBY write in this notebook.

The book which RUBY referred to as a guest book was described by PATTERSON as having the appearance of a small address book or small notebook, approximately 4 x 5 inches in size. He could not recall the color of the book nor could he recall whether it had a spiral back. PATTERSON stated he could not recall whether the man with RUBY handed the book back to RUBY or kept it himself.

About two days after the visit of RUBY and the man PATTERSON believes to be OSWALD were at the Electronics Shop, RUBY again appeared about 5:00 PM. On this occasion JACK RUBY was alone and brought with him a microphone and cable for repair. PATTERSON was instructed by RUBY to have the microphone and cable ready by 9:00 PM that night. PATTERSON stated he actually returned the microphone and cable to the Carousel at approximately 8:00 PM, and handed it over to a Negro boy employed by the Carousel Club. This individual paid PATTERSON in cash for the work and also paid PATTERSON a 50 cents parking fee which PATTERSON had incurred having parked on a nearby lot.

PATTERSON stated he could not recall seeing anyone else at the club on this occasion other than the Negro boy and possibly the Master of Ceremonies.

PATTERSON stated that it is his belief on the basis of the photographs of LEE HARVEY OSWALD which he has observed in various newspapers that OSWALD was in fact the individual present in the Electronics Shop with JACK RUBY on the occasion described above.

PATTERSON stated he has discussed this matter with his partner DONALD C. STUART and employee CHARLES ARNDT and he stated they are likewise of the opinion that LEE HARVEY OSWALD was the individual with JACK RUBY on the occasion described above. According to PATTERSON the man with RUBY in his shop on the occasion set out above was described as follows:

He was believed to have a tattoo on the left forearm; was wearing blue jeans (very tight fitting) and possibly a white shirt. He was not wearing a hat nor was he wearing a jacket.

After viewing these photographs PATTERSON selected the photograph of LEE HARVEY OSWALD, New Orleans No. 112723 and stated he believed that this photograph depicted the individual who was present in the Contract Electronics Shop with JACK RUBY on the occasion set out above.

PATTERSON stated that at the present time he is a student at the Metropolitan Technical Institution, 402 North Good-Latimer, Dallas, Texas. He stated he was born on January 24, 1930 at Lincoln, Nebraska, and had the rating of ED-3 while in the US Navy. His US Navy Serial No. is 4278665.

The name of DONALD C. STUART's wife is NANCY and they reside on Pleasant Street turning left off Second Street while driving away from the downtown area of Dallas, Texas. Their residence is in the first group of apartments on the lefthand side of Pleasant Street. He stated the number might possibly be 1314 Pleasant. According to PATTERSON, DONALD C. STUART is a full time employee of Radio Station KLIF, Dallas, Texas. He is employed as a broadcast engineer and is on duty at the station several nights a week.

PATTERSON stated that it is his understanding that DONALD C. STUART has reported this matter to the Dallas Police Department.
