FOUR AM AND BIRMINGHAM TEL TO BUREAU AND DALLAS DECEMBER FOURTEEN,
SIXTYTHREE, SIX TWENTYSEVEN PM, RE POSSIBLE ASSOCIATION BETWEEN
RUBY AND PAUL ROLAND JONES.

WFO ADVISED DALLAS DECEMBER SIX, SIXTYTHREE PAUL ROLAND JONES,
FBI NUMBER THREE NINE FOUR SEVEN ONE NINE, SENTENCED ON NOVEMBER
TWENTY, FORTYSEVEN, TO FIVE YEARS ON NARCOTICS VIOLATION. CONFINED
USP, LEAVENWORTH, KANSAS, WHERE PREVIOUSLY SERVED NINE YEARS OF LIFE
SENTENCE FOR FIRST DEGREE MURDER. CONDITIONALLY RELEASED IN NINETEEN
FIFTYTWO TO SHERIFF BILL DECKER, DALLAS, TO SERVE THREE YEAR TERM FOR
BRIBERY. HOUSTON ADVISED DALLAS DECEMBER SEVEN, SIXTYTHREE, JONES
DISCHARGED FROM TEXAS STATE PENITENTIARY, HUNTSVILLE, FEBRUARY
TWENTY, FIFTYTHREE AFTER SERVING TIME ON BRIBERY CHARGE. IT IS NOTED

REFERENCE BIRMINGHAM TEL RELATES JONES STATED JACK RUBY MUST HAVE BEEN PAYING OFF THE POLICE DEPARTMENT IN DALLAS, TEXAS, OTHERWISE HE COULD NOT HAVE OPERATED THE BUSINESSES AND BEEN PERMITTED TO PUT ON GAME RAW SHOWS UNQUOTE THAT HE DID. JONES SAID HE BASED THIS OPINION ON HIS, JONES, OWN ACTIVITIES IN QUOTE HAVING HAD TO PAY OFF IN ORDER TO OPERATE IN DALLAS UNQUOTE.

BIRMINGHAM REINTERVIEW JONES CONCERNING CIRCUMSTANCES OF ALLEGED PAYOFF, ATTEMPTING TO SECURE SPECIFIC NAMES OF OFFICERS TO WHOM PAYMENTS MADE, LOCATIONS WHERE SUCH PAYMENTS MADE, WHEN MADE, ETC., IN ORDER THAT DALLAS MAY ATTEMPT TO EVALUATE JONES STORY. ALSO OBTAIN SPECIFIC INFORMATION FROM JONES AS TO NATURE OF ILLEGAL ACTIVITIES ENGAGED IN WHICH PROMPTED SUCH PAYOFFS.

IN VIEW OF JONES BACKGROUND AND PAST ACTIVITIES, DALLAS RECOMMENDS THAT JONES OFFER TO ACT AS INFORMATION NOT BE ACCEPTED/ HOWEVER, BIRMINGHAM SHOULD OBTAIN ALL INFORMATION JONES CAN OFFER ABOUT RUBY.
