PAUL B. JONES REINTERVIEWED THIS DATE AND ADVISED HE MADE
PAYOFFS TO T. K. ERWIN, AN ATTORNEY NOW DECEASED. HE MADE
PAYOFFS ON A WEEKLY BASIS DEPENDING UPON THE NUMBER OF SLOT MACHINES
AND JUKE BOXES IN OPERATION IN THE AREA. THESE PAYOFFS STARTED ABOUT
NINETEEN FORTYFOUR AND CONTINUED UNTIL NINETEEN FORTYSIX AT WHICH
TIME GUTHRIE WAS ELECTED SHERIFF. PAYOFFS WERE IN AMOUNTS AS HIGH
AS EIGHT THOUSAND DOLLARS PER WEEK. HE SAID HE NEVER MADE
A DIRECT PAYOFF TO ANY MEMBER OF THE DALLAS PD OR SO AND COULD FURNISH
NO NAMES OF ANY MEMBER OF THE PD OR SO WHO RECEIVED PAYMENT THROUGH
HIS ATTORNEY T. K. ERWIN.

HE MET ERWIN THROUGH ATTORNEY [JOE CUNNINGHAM] WHO HE HAD RETAINED
TO HANDLE A CONTRACT OR SOME OTHER SIMILAR TYPE DOCUMENT. T. K. ERWIN
LATER CONTACTED HIM AND ASKED IF HE, JONES, WANTED TO OPERATE IN THE
AREA, STATING IT COULD BE ARRANGED. JONES OWNED APPROXIMATELY THIRTY
PERCENT OF THE SOUTHWESTERN AMUSEMENT COMPANY, WESTERN AMUSEMENT
COMPANY AND DELTA AMUSEMENT COMPANY. THESE COMPANIES INVOLVED IN
JUKE BOX AND SLOT MACHINE OPERATIONS.

JONES STATED THAT HIS MOTIVE OR REASON, WHICH HE DID NOT ADMIT
IN PREVIOUS INTERVIEWS, IN ASSERTING HIS WILLINGNESS TO ASCERTAIN
