CENTRAL AVENUE, LOS ANGELES, WHO WEARS SMALL RING ON OCCASION ON LEFT EAR, KNOWN TO FRIENDS AS QUOTE LITTLE BILL UNQUOTE, ADVISED TODAY WHEN INTERVIEWED THAT ON NOVEMBER TWENTYNINE LAST WHILE WEARING RING, VISITED ABOVE BAR, AMONG OTHERS, HAVING LOST JOB THAT DATE. HE QUOTE GOT PLASTERED UNQUOTE. HE HAS NO SPECIFIC RECOLLECTION OF WHAT HE SAID UNDER THESE CIRCUMSTANCES. HE REMEMBERS GENERAL EXPRESSIONS OF RESENTMENT BEING MADE BY PATRONS CONCERNING PRESIDENT-S ASSASSINATION AND SUBSEQUENT EVENTS. HE SAID HE MAY WELL HAVE MADE THE REMARKS IN QUESTION. HE HAS NO SPECIFIC KNOWLEDGE OF ANY MONEY OFFER, HOW IT MAY HAVE ENTERED THE CONVERSATION, AND CERTAINLY HAS NO CONNECTION WITH INDIVIDUALS IN POSITION TO KNOW OF OR MAKE SUCH OFFER.

GRAVES SAID HE MAY HAVE MADE SUCH STATEMENT AS HE WAS JOKINGLY QUOTED SEVERAL DAYS AGO IN INSTANT BAR BY ANOTHER TRUCKER WHO ASKED QUOTE WHAT-S THIS ABOUT SOMEBODY OFFERING SOMETHING. WELL, WHAT ARE YOU GOING TO DO, KNOCK OFF ME. RUBY. UNQUOTE. GRAVES REPLIED QUOTE WHAT ARE YOU TALKING ABOUT. I DON-T KNOW A THING ABOUT IT UNQUOTE. HE EMPHATICALLY STATES HE DOES NOT.

GRAVES DESCRIBED WMA, DOB JANUARY FIFTEEN TWENTYSEVEN, NEW IBERIA, LOUISIANA, FIVE SIX, ONE HUNDRED FORTY POUNDS, LIGHT BROWN HAIR, RECEDING HAIRLINE, BLUE EYES, SINGLE, PROTRUDING EARS, NORMAL OCCUPATION, TRUCK DRIVER, UNITED STATES NAVY VETERAN, DISCHARGED FORTYSEVEN. ADMITS VARIOUS DRUNK ARRESTS, NO OTHER CRIMINAL ARRESTS.

GRAVES CLAIMS HE DOES NOT KNOW EDWIN PHILLIPS BY NAME, BUT IS ACQUAINTED WITH VARIOUS DRIVERS FROM LATTER-S COMPANY WHO FREQUENT LOCAL BARS WHEN IN TOWN. HE DOES NOT HAVE ANY BUSINESS CARDS.

LOS ANGELES INDICES REFLECT NO IDENTIFIABLE INFORMATION CONCERNING GRAVES.

DUE TO INDIVIDUALS INVOLVED THIS MATTER DRINKING INTOXICANTS, FREQUENTING BARS, UAC NO ADDITIONAL INVESTIGATION BEING CONDUCTED LOS ANGELES THIS PORTION OF INVESTIGATION.
