DAVIS DECEMBER FOURTEEN, LAST AT MARTHA, TEXAS. DAVIS
LOGS REFLECT HE AND DORRIS WERE IN PHOENIX, ARIZONA NOVEMBER
TWENTYNINE LAST. DORRIS THERE ALL DAY UNTIL ELEVEN PM WHEN
