AM., TODAY AND DALLAS TEL TO BUREAU AND BIRMINGHAM ONE FIFTEEN
DECEMBER FIFTEEN LAST, BOTH RELATING TO PAUL ROLAND JONES.

AS STATED IN RE DALLAS TEL USE OF JONES AS INFORMANT IS NOT
RECOMMENDED BY DALLAS IN VIEW OF HIS BACKGROUND AND PAST
ACTIVITIES, AS SHOWN IN SEQUENCE OF PRIOR TELS SUBMITTED. FROM
STATEMENTS ATTRIBUTED TO HIM RE RE BH TEL HIS MOTIVES ARE HIGHLY
QUESTIONABLE AND APPEAR DESIGNED MORE TO USE OF BUREAU FOR
PERSONAL REMUNERATION AND GAIN, RATHER THAN ONE BASED ON SINCERE
DESIRE TO ASSIST, SINCE BY OWN STATEMENTS HIS KNOWLEDGE OF RUBY
LIMITED AND NOT CONDUCIVE TO DEVELOPMENT OF TYPE OF INFORMATION
INFERS CAN BE SECURED.

AS PREVIOUSLY INSTRICTED BH SHOULD OBTAIN ALL INFO JONES C
OFFER ABOUT RUBY AND HE SHOULD BE PINNED DOWN TO SPECIFICS ON
GENERAL STATEMENTS PREVIOUSLY MADE CONCERNING ALLEGED PAYOFFS TO
DALLAS LAW ENFORCEMENT BY JONES AND NATURE OF ILLEGAL ACTIVITIES
ENGAGED IN BY HIM NECESSITATING SUCH PAYOFFS.
