All information available in Chicago indices concerning subject and his family has previously been reported. A further review of Chicago files reflects information concerning Earl Products Company which is set forth herein.

In April, 1956, Chicago Park District Police Officer ELY BLUMENTHAL advised the Chicago Division that he was attempting to arrange the purchase of some obscene color film from MORRIS KLEINERMAN, Ideal Photo Supply Company, New York City, New York. BLUMENTHAL indicated that Earl Products Company of Chicago was to arrange for this purchase. Subsequent investigation reflected that Earl Products Company, Chicago, was owned or operated by one E. R. RUBY. In June, 1956, investigation at Chicago was discontinued inasmuch as no obscene films had been shipped by KLEINERMAN nor had any films been received by Earl Products Company.

There is no further identifying data in the Chicago file on which a determination can be made concerning E. R. RUBY or the Earl Products Company as to whether they are identical with EARL RUBY and the firm operated by him.

On 4/2/52 SA WILSON B. WADDY conducted a surveillance of [redacted] who on that evening attended a meeting at the home of [redacted] Chicago, Illinois. License numbers of all cars parked in the vicinity of the [redacted] residence were obtained, and one of these cars was listed to Earl Products, 701 North Sangamon Street, Chicago, on a 1950 Plymouth.

It should be noted that there is no indication in this file that the occupant of this particular car was attending the meeting mentioned above. It should be further noted that the address [redacted] is in the immediate vicinity of several of the former residence addresses of the RUBENSTEIN family, and particularly those residences of EARL RUBY.

It is not felt that the above information is pertinent to this investigation but is being furnished in order that the Bureau and the Dallas Division have all the information available from the Chicago Division files.

The surveillance, mentioned above, on [redacted] was conducted in connection with the CP-USA COMFUDS, IS - C investigation being conducted in Chicago during that period.
