His acquaintance with RUBY was so slight that he had no opportunity to learn anything about his activities or associates. He had never heard of LEE HARVEY OSWALD prior to the assassination of President JOHN F. KENNEDY and had no information to indicate any connection between OSWALD and RUBY.

GUEVARA stated that he formerly lived at 3420 Oak Grove which is the home of his parents.

HARRIS advised the club was managed by Mrs. EVA GRANT and as he recalls, he only saw JACK RUBY at the club on one occasion. He stated he, HARRIS, worked at the club from about 2:00 P.M. to 6:30 P.M.

HARRIS advised he knew nothing about JACK RUBY and that he had never spoken to him.

HARRIS advised he never saw LEE HARVEY OSWALD at the Vegas Club nor does he ever recall having seen him any place.

~~JOYCE HARVEY~~, 2221 Oak Lawn, telephone TA 6-1926, Dallas, Texas, was interviewed to determine reason for her name and telephone number appearing in RUBY's personal property. The name NANCY BACKER also appeared along with the name JOYCE HARVEY. Miss HARVEY furnished the following information:

During the early part of November, 1963, Miss HARVEY noted an ad in a Dallas daily newspaper which requested applicants for jobs at the Carousel Club in Dallas. Miss HARVEY telephoned the Carousel Club and spoke with JACK RUBY. Inasmuch as she did not wish her identity known, she told RUBY her name was ~~NANCY BACKER~~ and that she could be contacted through JOYCE HARVEY.

Miss HARVEY does not know RUBY personally, has had no contact with him other than the one telephone call, and knows of no connection whatever between RUBY and LEE HARVEY OSWALD.

RENEE MARIAN HAYES, nee ~~BIGMAN~~, 5015 Simpson, telephone TA 7-9604, Dallas, Texas, reported to be a former employee of JACK RUBY's, was advised she did not have to make a statement; that any statement she did make could be used against her in a court of law, and that she had the right to consult an attorney. She furnished the following information:

Mrs. HAYES stated she worked for JACK RUBY from December, 1962, to February, 1963, as a cigarette girl. Her duties required her to drink champagne with the customers, and after it was found that she was consuming too much champagne nightly, she was asked to terminate her employment.

She last saw JACK RUBY at the Vegas Club sometime in October, 1963, date unknown. She furnished the names of ANNE HAMILTON, believed to be residing in Dallas, and BETTY GUESS of Houston, Texas, as co-employees of RUBY. She said both HAMILTON and GUESS had dated RUBY and she believed they could furnish information concerning him. *Tex*

Mrs. HAYES did not know LEE HARVEY OSWALD, had never seen OSWALD and RUBY together and knew nothing of RUBY's travels. She did see police officers of the Dallas Police Department in the Carousel Club at least once a night, but did not know of any particular police officer with whom RUBY was particularly close. She knew of no conspiracy between RUBY and any other individual to kill OSWALD, and knew of no organizations to which RUBY belonged.

**BARBARA LEE HIGGINBOTHAM, 514 East Main,  
Denison, Texas, advised as follows:**

She stated that in April of 1962, she was employed in Dallas, Texas by Kelly Girls and was located at the Anderson Studios. Miss HIGGINBOTHAM advised that during April, 1962, she accepted a date with a gentleman, name not recalled, and during the course of the evening was introduced to JACK RUBY while drinking at the Carousel Club. At that time, JACK RUBY offered her a position at the Carousel Club as a stripper. Miss HIGGINBOTHAM stated she enrolled for lessons as a stripper at the Carousel Club and for approximately six weeks practiced frequently at the Carousel Club under the supervision of a veteran stripper employed by JACK RUBY. During this period, she frequently saw JACK RUBY, visited his apartment and became quite friendly with him, but not intimate. Miss HIGGINBOTHAM said she last saw JACK RUBY in September, 1963.

She stated that during her acquaintanceship with RUBY she never saw LEE HARVEY OSWALD or ever heard his name mentioned. She further advised that at no time did RUBY give any inclination of violent actions or actions which would indicate the future shooting of LEE HARVEY OSWALD.

HOMER JEFFERSON, 1900 Peabody, Dallas, Texas, was advised that the following person, with accompanying address and date, was listed as an employee of JACK RUBY at one of RUBY's clubs:

"HOMER JEFFERSON, 3215 Colonial, September 19, 1960"

JEFFERSON stated that the above HOMER JEFFERSON is undoubtedly him because he resided at 3215 Colonial, Dallas, in 1960 and he was employed by JACK RUBY in his night club on Commerce Street in Dallas. JEFFERSON stated that sometime in 1960, he believes, while employed as a porter at the "Dallas Morning News," RUBY approached him and asked if he would like to make some extra money by helping his cook at the club. JEFFERSON said that prior to the time RUBY approached him regarding the above employment, he had seen RUBY frequently at the "Dallas Morning News" placing his night club ads, but he had never engaged in any conversation with RUBY and he had no prior association with him. He accepted RUBY's offer and worked for him intermittently for three or four weeks, or possibly over a two months period, during 1960, he believes. He added he has not seen RUBY since he left RUBY's employ.

JEFFERSON advised that RUBY operated a "clean," legitimate business and to the best of his knowledge RUBY was not engaged in any illegal activities during the time he worked for RUBY. He knew nothing about RUBY's personal life and he knew none of RUBY's close friends or acquaintances. Furthermore, he did not know if RUBY had friends on the Dallas Police Department.

JEFFERSON stated that LEE HARVEY OSWALD was unknown to him and he knew of no associatin between RUBY and OSWALD.

Mrs. JANICE ~~NORMAN~~ *Jones* JONES, also known as NEESIE, a former waitress at the Carousel Club, furnished the following information:

She was employed by RUBY at the Carousel Club as a waitress from December 1, 1962, until July, 1963, and she obtained this job after reading an advertisement in the Dallas Morning News. She recalls that RUBY was a generous person who gave Christmas gifts to his employees and also recalls RUBY gave a Thanksgiving dinner and a Fourth of July party for his employees during the time she worked for him. RUBY also gave a fifth of whisky to each policeman who would come into his club during the Christmas season. He also would not take any money from these policemen when they visited his club at other times during the year. She is unable to identify any of these police officers by name.

She recalls RUBY took only one trip during her employment and that was to Edna, Texas, to visit a person named CANDY BARR. She understands that CANDY BARR had just been released from prison at this time. The last time she saw RUBY was at the Carousel Club on the night she quit and does not remember ever seeing LEE HARVEY OSWALD in the Carousel Club. She does not know of any connection between RUBY and OSWALD.

LEE WESLEY JONES, 4713 Zealand Street, whose name and address appeared on a list of former employees of JACK RUBY, furnished the following information:

JONES advised that about two years ago he was employed for a period of five or six months by JACK RUBY at the Sovereign Club, now known as the Carousel Club. He played the piano in a small colored combo with MILTON THOMAS, saxophone, now employed at the Vegas Club, WILLIAM NELSON, drummer, now employed at the Club Galaxy and JAMES GRAY, bass violin, now employed in the music department of the Booker T. Washington High School.

JONES stated his employment, as stated above, was the extent of his acquaintance and association with RUBY, and that since this employment, he has not kept up with RUBY or associated with him but did see him on the street in Dallas a few times. He stated he last saw RUBY two months ago and merely spoke to him at that time. JONES added that he never knew or saw LEE HARVEY OSWALD, that he never received any information indicating a possible relationship between OSWALD and RUBY and has no information concerning the shooting of OSWALD on the part of RUBY.

He stated he was only helping out CHARLES DRIGGERS who was to be the permanent bartender at the club. He does not recall meeting JACK RUBY and had never heard of LEE HARVEY OSWALD before OSWALD's murder and did have no idea of any connection between JACK RUBY and LEE HARVEY OSWALD.

CHERIE LAMOUR, Route #2, Grand Prairie, Texas, telephone AN 2-3362, advised her name could appear among the papers of JACK RUBY as a former employee of his.

She has worked as a stripper for about the past five years primarily filling "club dates." She has never worked for RUBY or for any burlesque house as a permanent employee, preferring to fill the one day club dates several days a week instead. She has contacts with numerous booking agents throughout the southwest and secures most of her work as club dates from these agencies. RUBY has her telephone number and has called her to perform on several occasions in the past when one of his regular girls was off. She estimated she has worked for him for a day to three days on about five or six occasions during the past three years. The last time she worked for him was a one-night engagement about six or eight months ago.

She advised that her association with RUBY was very satisfactory and that he paid her well, treated her like a lady and never argued with her or created any problems. Shortly after she first went to work for him he asked her to work for him regularly but she declined to do this because of her desire to fill club dates. She explained that she can make as much money filling three or four club dates as she could working steadily for RUBY or at any other burlesque house. She advised that she has never worked for RUBY performing at any club dates or private parties. She knew of no such parties for which he furnished entertainment.

She was not acquainted with LEE HARVEY OSWALD, knew of no association between OSWALD and RUBY and knew of no other individuals possibly involved with either of these two men in the shootings.

Mrs. DUANE <sup>\*</sup>McCARTY, General Delivery, was advised that her maiden name, CYNTHIA ANN WITT, appeared on a list of former employees of RUBY and she was asked for any pertinent information she could furnish concerning him. *Frisco, Tex.*

Mrs. McCARTY advised that she was employed by RUBY as a cocktail waitress for approximately two or three weeks about 1959 or 1960 when he first opened the Sovereign Club. At this time the Sovereign Club had a good clientele inasmuch as it was a private club. She did not get to know RUBY very well during the two or three week period she was employed by him. She has ~~never~~ known LEE HARVEY OSWALD and had no information indicating any connection between RUBY and OSWALD.

Mr. **SHELLEY BURNS MYERS**, 433 East Jefferson, Dallas, Tex. Telephone Number WH 8-9384, who is a clinical psychologist often referred to as a hypnotist, was contacted at which time he furnished the following information: *Shelley Myers*

He advised that he first met JACK RUBY approximately two years ago and that to the best of his recollection he had met RUBY at the Carousel Club. He could not recall the exact circumstances surrounding the meeting of JACK RUBY, however, he could recall working for JACK RUBY at the Carousel Club on four or five occasions as a hypnotist. He could recall that on one particular occasion in December, 1961, he was putting on a show at the Carousel Club and had hypnotized SANTA CLAUS, and for this reason could remember that it was around December, 1961. Mr. MYERS stated that he had a few conversations with JACK RUBY during the time he was employed by the Carousel Club, but could not recall ever discussing any political views or anything that would pertain to RUBY's background.

MYERS has developed several personal views of JACK RUBY since the shooting of LEE HARVEY OSWALD and stated that these are only his personal opinions and could not be substantiated by any particular fact. He related that JACK RUBY was an individual who was continually being "picked on" and for this reason he regarded JACK RUBY as being somewhat of an underdog. He was under the impression that RUBY had always wanted to be a big "star" and would do anything to attain this goal. Although he could offer nothing specific, Mr. MYERS had gained the impression that RUBY shot OSWALD because RUBY had his one chance to be something. He stated that he believed that RUBY was well aware of what he was doing and that he did shoot OSWALD strictly on his own.

Mr. MYERS stated that he would be unable to furnish any specific information concerning RUBY's background and associates, and knew of no one who had possibly conspired with RUBY to shoot OSWALD. OSWALD is unknown to him and he could offer no information that would connect OSWALD and RUBY.

Garland, Texas, Telephone BR 6-8249, advised she formerly  
 resided at 6233 Vickery and was a former employee of JACK RUBY.

Mrs. POORE advised that shortly after World War II she worked at the Martha Washington Candy Store on South Akard Street, downtown Dallas. She met JACK RUBY at this time, who apparently was staying at or visiting the Adolphus Hotel on East Commerce Street. She obtained a job from RUBY at the Silver Spur Club on South Harwood, where she worked four or five weekends as a cashier.

Mrs. POORE stated that after RUBY opened the Vegas Club, she obtained employment from him as a cashier and later as a waitress at this club. She estimates that she worked at the Vegas Club off and on over a period of three to four years. RUBY also operated the Sovereign Club and she handled the money for him at this club on occasion. She left his employ while at the Sovereign Club approximately three years ago and, in fact, that is the last time she has seen him or talked to him.

Mrs. POORE stated that in 1958, she was re-married and was formerly known as DOROTHY GRIMES. In fact, JACK RUBY always called her DOROTHY GRIMES.

During her association with RUBY, she also became acquainted with RUBY's sister EVA GRANT and at one time considered EVA to be her closest friend. They had a falling-out three to four years ago and she has not seen EVA or talked to her since that time.

She stated that to her knowledge RUBY never knew LEE HARVEY OSWALD and she personally never saw OSWALD at any of these clubs. She can offer no information as to how RUBY may have entered the Dallas Police Department Building, nor can she give any information on any possible conspiracy between RUBY and any policeman. She added that RUBY knew many policemen throughout the years as they frequented his clubs, some off-duty and some apparently watching him. As related above, she has not

seen RUBY in three years and can furnish no information as to his activities on the day of the President's assassination and immediately thereafter. She considered JACK RUBY a good man and considered the Vegas Club and the Sovereign Club to be high-class places, at least while she worked in them. She has never worked at the Carousel Club and knows nothing about it.

She would describe RUBY as an individual who wanted to be in the forefront of everything, and would actually relish police visiting his clubs. She never associated with him other than during working hours and can offer no information as to his conduct of his personal life, although always considered him a normal man with normal passions.

As reiterated above, Mrs. POORE stated that five years ago she was remarried and has not seen RUBY or EVA in three years and can furnish no information as to their recent activities.

CHARLES DOUGLAS PRICE, 3301 Colby Place, residence telephone TA 4-1582, Dallas, Texas, furnished the following information:

*NEGRO*

PRICE is presently employed at the Famous Door, 1441 N. Zang Street, telephone WH 3-0077. He has known JACK RUBY since about 1950 and has worked for him and his sister, EVA GRANT.

PRICE said he first met RUBY at the Silver Spur and also worked at the Vegas Club, operated by GRANT. He was hired as a bartender when the Sovereign Club was opened in about 1959 and acted as the manager on occasions.

As concerning JACK RUBY's background, all that he could recall was that RUBY talked frequently about Chicago and the fact that he spent his earlier life there. He did not know much concerning RUBY's personal life or his close friends. Employees change frequently at the clubs RUBY operated and he could recall no one in particular that worked for RUBY.

PRICE described RUBY as a peculiar individual, whose emotions fluctuated frequently. On one occasion at the Sovereign Club in about 1960, 14 Japanese staying at the Adolphus Hotel came to visit the club. They had apparently received club passes from one of the managers at the Adolphus. He was managing the club that evening and when RUBY arrived at the club, he became highly irritated with him and called him a "stupid, black S.O.B." and told him to get them out of the club. RUBY said that the white customers would leave if they found Japanese in the club. He said to RUBY that he was a Jew and I am a Negro, and Jews and Negroes are the most hated people on earth. He told him that he should be more tolerant of people like the Japanese and that if he ever called him a "black S.O.B." again, he would cut him up and kill him. RUBY threatened to kill him at that time and he immediately terminated the discussion and quit his job. He stated he felt at the time that RUBY was temperamental enough to be capable of killing

someone as highly excited as he was that evening.

PRICE also recalled that during that same period of time, the porter named GEORGE (LNU), who was on the verge of being an alcoholic, had locked the doors to the club and fell asleep in RUBY's office. GEORGE was apparently drunk at the time and he was there when RUBY found him. RUBY hit GEORGE across the head with his fist and when that failed to arouse GEORGE, RUBY took out a pistol from his pocket and "pistol whipped" him until he woke up. GEORGE immediately ran from the building and the next day RUBY asked him to locate GEORGE and relay his apology and tell him to come back to work. RUBY also got in touch with him on the occasion that he quit and asked him to come back to work which he did. Normally RUBY was friendly and nice to him, but as he was with other employees, he violently lost his temper on occasions.

RUBY made it a point to contact many of the hotel people in downtown Dallas and would give them pass cards to the club requesting that they pass them out to guests at the hotel. He also recalled that he personally, by RUBY's bidding, gave out pass cards to bellboys that he knew in the downtown area.

RUBY wanted to be known by all the "big people" in Dallas and make it a point to be friendly with attorneys and public officials. He never knew of any police officers that RUBY was particularly friendly with, but he seem to know them all and treated them like friends.

He never heard RUBY express any political convictions and has no ideas as to why RUBY shot LEE HARVEY OSWALD. He never heard of OSWALD prior to the President's assassination and knows of no connection between RUBY and OSWALD.

Miss GERRY REDIN, also known as SHARON BEVINS and CANDY CANE, was located at her place of employment, The Red Mill Club, Juarez, Mexico, and was interviewed in the presence of Detective J. REFUGIO RUBALCAVA M. of the Juarez Police Department.

REDIN advised that she had worked for JACK RUBY for approximately eight weeks in late 1959 or early 1960 at the Carousel Club, Dallas, Texas, as an exotic dancer. She met RUBY at the time while she was a free agent and looking for work. She knew from general knowledge that he employed exotic dancers in his clubs. Her association with RUBY was limited to the terms of her contract though she came to consider him a friend. She has not seen him since termination of her contract. She further advised that she did not know LEE OSWALD nor did she have any knowledge of any contact or friendship between OSWALD and RUBY.

REDIN recalls RUBY as a non-violent person, who to the best of her knowledge, was well liked by everyone who ever worked for him. She recalls one incident in particular where a drunk got violent in the Carousel Club and smashed an expensive mirror. RUBY did nothing more than ease the drunk out of the club. RUBY was a great friend of the Dallas Police Department and would usually buy drinks for any officer who came in the club whether on duty or off. She noted that perhaps as a result of this, the Dallas Police never bothered RUBY when he held stag parties.

REDIN expressed the opinion that RUBY had a "persecution complex" and as a result, felt a great need for friendships. He most frequently tried to "buy" these friendships with free drinks at the club. She further advised that based on her knowledge of RUBY she could not imagine that he would do such a thing as shooting anyone nor could she imagine what reason he might have had.

REDIN advised that her professional manager is LILLIAN MC CARDALL, 1825 Rosedale, Houston, Texas, telephone JA 2-4555 and that MC CARDALL knows RUBY well. She also recalls that RUBY supported a "stripper" by the name of KITTY, last name unknown, who worked for some time in New Orleans, La. before going to Dallas, Texas. KITTY was apparently disliked intensely by RUBY's sister who served as manager of the Carousel Club while she, REDIN, was there.

REDIN noted that she will be working in Juarez, Mexico for approximately another six months under her professional name of CANDY CANE, the same name she used while working for RUBY.
