MARTHA STANTON CHADWELL, NINE FOUR ZERO EAST HAVENS ST., KOKOMO, INDIANA, INTERVIEWED AND UNABLE TO FURNISH SPECIFIC INFO CONCERNING WORDS USED BY BOB WALKER STATING SHE HAD IMPRESSION WALKER MENTIONED RUBY/S NAME PRIOR TO SHOOTING OF OSWALD BUT STATED MIGHT HAVE BEEN MISTAKEN. MRS. CHADWELL HAS CONTACTED INDIANAPOLIS OFFICE TELEPHONICALLY THREE TIMES COMPLAINING OF SOMEONE LISTENING IN ON HER TELEPHONE AND GIVING IMPRESSION OF BEING POSSIBLY MENTALLY UNBALANCED. MRS. CHADWELL KNOWN TO KOKOMO PD AND CONSIDERED BY THEM TO BE MENTALLY UNBALANCED.

LETTERHEAD MEMORANDUM AND THREE ZERO TWO REFLECTING INTERVIEW BEING SUBMITTED.

ONLY POSSIBLE WAY KNOWN TO FULLY RESOLVE WHAT BOB WALKER SAID PRIOR TO OSWALD/S SHOOTING WOULD BE TO REVIEW TAPE OF BROADCAST.
